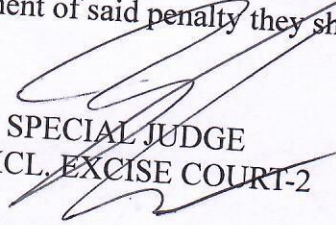

informed. No external physical injury found on their body. The I.O. has submit
form VI as per Rule 18 of the Bihar Prohibition and Excise Rules 2022.

On perusal of F. I. R, form VI, breathe analyser report (BAC) and other mater
available on record that a prima facie case U/s 37 of the Bihar Prohibition and Exc
Rules act 2016 is made out against the aforesaid accused persons and according
cognizance is taken.

The accusation is explained to the accused persons to which they pleads guilt
The depositions of the accused persons have also been recorded in form VI-A as pe
Bihar Prohibition and Excise Rules 2022. They further say that it is their first
offence.

Having considered aforesaid including the fact that the accused persons hav
pleaded their guilt voluntarily and also stated that it is their first offence for consumin
the liquor U/s 37 of the Bihar Prohibition and Excise Rules act 2016 and they woul
not repeat said offence in future and there is nothing in the record to show that th
accused persons were earlier convicted for the offence U/s 37 of the Bihar Prohibition
and Excise act 2016, the accused persons are convicted and sentenced to deposi
penalty of Rs- 2500/- each and on default of payment of said penalty they shal
undergo simple imprisonment for 30 days.
