CHARGES WITH FOUR HEADS
[NO.XXVII(II) SCHEDULE V, ACT V, 1898]
(Sections 221,222,223, Code of Criminal Procedure)

I, Sri Tarak Nath Bhagat
Additional Sessions Judge,
4th Court, Murshidabad
Berhampore, West Bengal.

hereby charge you –

**Bikash Mondal, Mira Mondal and Milan Mondal Hossain ,
Moji Sk. @ Mojibur Rahaman and Sarifan Bibi @ Shariful Bibi** as follows:-

Firstly, that you- on 24.11.2018 at 4:00 P.m. at village Kajipara (Guripara) under P.S.Jalangi , Dist. Murshidabad, in furtherance of common intention committed criminal trespass into the house of Mritunjoy Mondal and Kalpana Mondal and that you all thereby committed an offence punishable under Section 448/34 of I.P.C., and within the cognizance of this Court.

Secondly, that on the aforesaid date, time and place, you, in furtherance of common intention voluntarily caused grievous hurt to Mritunjoy Mondal and Kalpana Monda by assaulting them with hasua upon their face and head and that you thereby committed an offence punishable under Section 324/34 of I.P.C., and within the cognizance of this Court.

Thirdly ,that you on the said date, time and place, in furtherance of common intention attempted to commit murder of Mritunjoy Mondal and Kalpana Monda by assaulting them with hasua upon their head and that you thereby committed an offence punishable under section 307/34 of the Indian Penal Code, and within the cognizance of this Court.

Fourthly , That you on the said date, time and place, in furtherance of common intention criminally intimidated Mritunjoy Mondal and Kalpana Monda and that you thereby committed an offence punishable under section 506/34 of the Indian Penal Code, and within the cognizance of this Court.

And I hereby direct that you be tried on the said charge.

Substance of the charge of the offence punishable under the aforesaid section so framed against accused persons as mentioned here-in- above is read over and explained to them in Bengali to which they pleaded not guilty and claimed to be tried.
