Today is fixed for appearance of accused on court bail, production of four accused persons, confirmation of bail of accused persons Sk Mosidul Islam, Samiul Islam, Masidul Sk, Lokimuddin Sk and Saiful Sk and filing voklatnama by accused persons namely, Samiul Islam, Masidul Sk, Lokimuddin Sk and Saiful Sk.

Out of (57) accused persons, four accused persons namely, Hazrat Ali, Sadik Sk @ Sadikuzzaman, Abu Sufian @ Bhutal and Osman Gani @ Ushman Gani are produced from JC.

Forty-six(46) accused persons on court bail are present in court by filing hazira along with their Ld. Counsel.

Three(3) accused persons namely Samiul Islam @ Samiul Haque (CS accused No. 22), Lokimuddin Sk @ Lokomoddin @ Nakibuddin Seikh (CS accused No. 32) and Saiful Sk @ Saiful Islam (CS accused No. 38) are absent without steps.

Hence, the bail bond of accused Samiul Islam @ Samiul Haque (CS accused No. 22), Lokimuddin Sk @ Lokomoddin @ Nakibuddin Seikh (CS accused No. 32) and Saiful Sk @ Saiful Islam (CS accused No. 38) are forfeited.

Issue WA against the accused Samiul Islam @ Samiul Haque (CS accused No. 22), Lokimuddin Sk @ Lokomoddin @ Nakibuddin Seikh (CS accused No. 32) and Saiful Sk @ Saiful Islam (CS accused No. 38).

Start proceedings U/Sec. 491 of BNSS against the sureties.

Let a copy of this order along with bail bond be forwarded to the Court of Ld. Chief Judicial Magistrate, Murshidabad for information and taking necessary action.

Other two(2) accused namely, Masidul Sk @ Md Masidul Haque (CS accused No. 23) and Sk Mosidul Islam (CS accused No. 43) filed a petition, praying for remaining them on same bail bond.

The prayer is considered and **allowed**.

The voklatnama filed on behalf of Masidul Sk @ Md Masidul Haque (CS accused No. 23) is kept with the record.

The two accused namely, Ajibur Rahaman @ Md Ajibur Rahaman (CS accused No. 7) and Suruar Hossein @ Sanowar Hossein (CS accused No. 10) are present by petition.

NER of WA is received in respect of accused Hazrat Ali @ Bhudev(CS accused no. 15).

Issue reminder in respect of accused Hazrat Ali @ Bhudev(CS accused no. 15).

Accused **Raju Mandal** (CS accused No. 57) surrenders by petition along with voklathnama of his engaged Ld. Counsel. Copy served.

Accused **Raju Mandal** is taken into custody and remanded to J/C.

Recall W.A. at once.

Another application is filed on behalf of this accused **Raju Mandal**, praying for bail on the grounds stated therein, is taken up for hearing.

Ld. Counsel for the accused as well as Ld. P.P. are present.

Heard both sides.

Perused the application for bail and the case record.

It appears that previously the accused person was on bail, but subsequently, being absent before this Court, Warrant of arrest was issued against him on 17.04.2025 as he could not attend the proceeding of the Court.

Considering all, as the accused petitioner voluntarily surrendered before this Court and for the first time he made himself absent from attending the proceeding of this Court, I am of the view that another opportunity should be given to the accused petitioner for appearance before this Court by allowing the instant application for bail. Accordingly, the prayer for bail stands **allowed**.

The accused petitioner, namely, **Raju Mandal** may be enlarged on bail on furnishing bond of **Rs. 6,000/-** with two sureties of **Rs. 3,000/- each**, **other than previous sureties**, subject to the satisfaction of the Ld. C.J.M Murshidabad.

Let a copy of this order be sent to the Ld. C.J.M. Murshidabad for information and taking necessary action.
