JUDGMENT

The accused stands charge-sheeted for the offence punishable under Section U/s. 305 (C) of the B.N.S..

2. The accused is produced before the Court through Video Conference. The accused voluntarily pleaded guilty as per the aforesaid plea. Hence, I proceed to pass the following order:-

ORDER

1. Accused viz. Surykant Vasantrao Kandekar, is convicted vide section 275 of the B.N.S.S. for the offence punishable 305 (C) of the B.N.S. and he is sentenced to suffer Rigorous Imprisonment for 03 (Three) months and to Pay fine of Rs. 5,000/- (Five Thousand) in default of payment of fine accused is sentenced to suffer Simple Imprisonment for 15 (Fifteen) days.
2. The period of detention, if any undergone by the accused during investigation/inquiry or trial of the case, be set off from the term of imprisonment imposed on him vide section 468 of the B.N.S.S..
3. The seized muddemal property is already returned to the authorized person i.e. informant. Indemnity bond executed by informant stands cancelled after appeal period is over.
4. The copy of this Judgment be given to the accused free of cost.
