The accused persons filed a petition praying for pleading the guilt.

Heard the submissions of the Ld. Advocates of both the sides.

The petition praying for pleading guilt is considered.

The accused persons are again examined u/S. 251 Cr.P.C.

The substance of accusation punishable u/Ss. 448/323/427/506/34 of the Indian Penal Code, 1860 is read over and explained to the accused persons to which they plead guilty saying “আমরা দোষী”.

Hence, it is

O R D E R E D

That the accused persons, namely, **1. Mojibar Sarder, 2. Esab Sarder, 3. Akkas Sarder and 4. Bahadur Sarder** are convicted u/S. 252 of Cr.P.C. for offence punishable u/Ss. 448/323/427/506/34 of I.P.C. and sentenced to suffer simple imprisonment till rising of this Court today and sentenced to pay a fine of Rs. **200/- each** for the offence punishable under Section 341/34 of I.P.C. i.d. to suffer S.I. for 3 days, Rs. **300/- each** for the offence punishable under Section 323/34 of I.P.C. i.d. suffer to S.I. for 5 days and sentenced to pay a fine of Rs. **100/- each** for the offence punishable under Section 427/34 of I.P.C. i.d. to suffer S.I. for 2 days and Rs. **100/- each** for the offence punishable under Section 506/34 of I.P.C. i.d. suffer to S.I. for 2 days, which shall run concurrently.

Release the convicts after fine being paid i.d. to J.C.
