Out of three (03) C.S. accused persons; two (02) C.S. accused persons, namely, Azad Sk and Ajmat Sk @ Aju on C/B are present by filing respective haziras.

One (01) C.S. accused person, namely, Mostafa Sk @ Musta is produced from J.C. through V.C. He is remanded to J.C. till next date.

C.S. accused person, namely, Ajmat Sk @ Aju on C/B files a petition praying for confirmation of his interim bail.

Ld. APP and Ld. Advocate on behalf of the accused persons, both are present.

Heard. Perused the petition. Considered.

Interim bail of accused person, namely, Ajmat Sk @ Aju granted by this Court on 14.01.2026 is hereby confirmed as regular bail.

Now, the case record is taken up for commitment.

Heard both sides. Perused the case record.

It appears from the case record that Charge Sheet has been submitted u/Ss. 392/412 of I.P.C., which is exclusively triable by the Court of Sessions.

Copies have been supplied to the accused persons on CB in compliance with the provision of Section 207 of Cr.P.C. and the case is ready for commitment.

Let the case be committed to the Court of Ld. Sessions Judge, Murshidabad in view of provision contemplated u/s. 209 of Cr.P.C.

Accused persons, who are on bail, have filed a petition praying for permitting them to remain on the same bond and it is submitted that they were granted bail and never misused the liberty given to them and in that view of the matter they may be allowed to remain on bail on previous bond.

Ld. APP also does not oppose the same.

On proper consideration the accused persons who are on bail are permitted to remain on previous bonds subject to confirmation by the Ld. Sessions Judge.

Send the record of the case, documents and articles, if any, to the Ld. Sessions Judge, Murshidabad. G.R.O. to handover C/D to Ld. P.P. in-charge at once.

Notify the Public Prosecutor of the Sessions Court about the commitment of the case.

To 02.05.2026 for production of accused Mostafa Sk @ Musta and appearance of rest two (02) C.S. accused persons who are on court bail before the Ld. Sessions Judge, Murshidabad positively.

Surety to produce the accused persons on court bail before the Ld. Court of Sessions Judge, Murshidabad on the date fixed and to submit compliance report.

The Superintendent, B.C.C. Home is directed to produce the accused Mostafa Sk @ Musta before the Ld. Sessions Judge on 02.05.2026.
