ORDER

1. Present bail application has been filed under Section 439 Cr. P.C on behalf of above said accused/applicant for grant of regular bail in the aforesaid FIR. Notice of the application was given to State and record of the case was produced.
2. The brief facts of the prosecution case necessary for deciding

present bail application are that on 04.09.2018 in the area of Kumbra chowk Mohali, accused/applicant was found in possession of 260 grams of Opium, without any permit or license. Hence, this bail application.

3. I have heard learned counsel for accused/applicant, learned Additional P.P for the State and have carefully perused the record with their able assistance.

4. As per the case of prosecution, applicant/accused was found in possession of 260 grams of Opium on 04.09.2018, which is falling in the circle of non-commercial quantity. Applicant is in custody since 04.09.2018. No useful purpose would be served by detaining the accused/applicant in judicial custody for an indefinite period. The presentation of challan in Court and trial thereof will take sufficient long time. As such, the accused/applicant is ordered to be released on bail, on his furnishing personal bond in the sum of Rs.1,00,000/- with one surety in the like amount, subject to the conditions that accused/applicant will appear in Court on each and every date of hearing and will not leave the country without prior permission of the Court. Bail application stands allowed accordingly. Papers be attached with concerned file, if any, otherwise consigned to the record room.
