Out of three (03) C.S. accused persons; two (02) C.S. accused persons, namely, Md. Sakib Hosan and Md. Zahidul Islam @ Rintu are physically produced from J.C. and they file a petition praying for pleading guilty to the offence charged against them.

One (01) C.S. accused person, namely, Najbul Mondal on C.B. is absent by petition praying for fixing another date for his appearance.

Ld. Advocate for the accused persons and Ld. A.P.P for the State, both are present.

Petition praying for pleading guilty filed by the accused persons, namely, is taken up for hearing.

Heard both sides. It transpires from the record that charge sheet has been submitted in this case **u/Ss. 21/24 of the Immigration and Foreigners Act, 2025.**

Accused persons, namely, Sakib Hosan and Md. Zahidul Islam @ Rintu are Bangladeshi citizens.

Considering all, charge is framed **u/S. 21 of the Immigration and Foreigners Act, 2025** against accused persons, namely, Sakib Hosan and Md. Zahidul Islam @ Rintu and the substance of accusation is read over and explained to them and being asked, they plead guilty by saying that they have committed the offence.

Having perused the materials on record and also heard both sides, plea of guilt appears to be made voluntarily and hence, it is accepted and, accordingly, accused persons, namely, Sakib Hosan and Md. Zahidul Islam @ Rintu are convicted for punishable offence u/s 21 of the Immigration and Foreigners Act, 2025 in view of Section 264 of B.N.S.S.

Hence, the convicts, namely, Sakib Hosan and Md. Zahidul Islam @ Rintu are sentenced to S.I. for **nine (09) months each** and also to pay a fine of **Rs.10,000/- each i.d. S.I. for thirty (30) days each** for the offence punishable u/S. 21 of the Immigration and Foreigners Act, 2025.

Issue Jail Warrant accordingly.

The convicts, namely, Sakib Hosan and Md. Zahidul Islam @ Rintu are in custody since 23.01.2026 and their period of detention would be set off with substantial part of the sentence u/s 468 of B.N.S.S..

The Superintendent, Berhampore Central Correctional Home is directed to proceed with the matter of push back of the convicts to their native land after completion of their sentence.

Let a copy of this order be sent to the Superintendent, Berhampore Central Correctional Home for information and compliance.

Let another copy of this Order be given to convicts free of cost in terms of Section 404 of B.N.S.S. read with Rule 251 of Calcutta High Court Criminal (Subordinate Courts) Rules, 1985.

Fix 20.08.2026 for appearance of accused person, namely, Najbul Mondal.
