Today is fixed for S.R in the instant matter .
The petitioner is present by filing hazira

The application under Sections 12 and 18 of the Protection of Women from Domestic Violence Act, 2005 (hereinafter “the Act”) filed by the aggrieved person has been placed before this Court.

The Court has perused the application, affidavit, and accompanying documents.

1. Ex-parte Consideration

Upon a prima facie satisfaction that the aggrieved person has been subjected to domestic violence as defined under Section 3 of the Act, and noting that any delay in granting protection may cause further harm or prejudice to the applicant, this Court is satisfied that an **ex-parte protection order** is warranted under Section 23(2) read with Section 18 of the Act.

2. Protection Order Under Section 18 of the Act

Accordingly, the following directions are issued **ex-parte**:

1. **The Respondents** are hereby **restrained from committing any act of domestic violence** against the aggrieved person.
2. The Respondents are further **restrained from approaching, contacting, communicating, threatening, or intimidating** the aggrieved person in any manner whatsoever, either directly or indirectly.
3. The Respondents shall not enter into the place of residence / shared household of the aggrieved person located at **located at Mouza 128 Jainagar P.S. Rejinagar and Distict Murshidabad in the name of Salma Khatun being plot no L.R. No 661.**
4. The Respondents are restrained from injuring, harming, or interfering with the aggrieved person’s employment, relatives, dependents, or any person assisting her.
5. The Respondents are prohibited from alienating or disposing of any assets, bank accounts, or stridhan belonging to the aggrieved person without the permission of this Court.

3. Direction to Police for Implementation

In exercise of powers under Section 18(e) and Section 28 of the Act, it is hereby directed that:

1. **The Officer In charge ,Rejinagar Police Station,** shall **ensure strict compliance and enforcement** of this Protection Order.
2. The **Officer In charge** shall **provide necessary assistance and protection** to the aggrieved person as required, including preventing the respondents from entering the house of aggrieved person or approaching the applicant in violation of this order.
3. A copy of this order shall be **immediately served** upon the The Officer In charge of Rejinagar Police station for implementation.

4. The Officer In charge of Rejinagar Police station shall file a **compliance report** before this Court on or before the next date of hearing.
5. The Requisite for D.I.R is filed .
6. Let it be issued
7. B.C II to comply the order.

The other relief are kept in abeyance and the same will be considered after appearance of the opposite party.
