Examination-in-chief by Smt. Nalini Dandge, Advocate, holding for Smt. Monali Pathade, learned Advocate for the petitioner :

I am MBBS, MS Ortho. and run Abhiyog hospital.

2] Patient namely Navin Thawarbhai Rabari, 25 years old male, was admitted in hospital on 5/1/24 and discharged on 7/1/24. He was admitted for removal of left proximal humerus plate. He was operated on 6/1/24. Now I am referred with discharge summary, it is signed by me, it is correct, marked as **Exh. 61.**

3] Now I am referred with bill dt. 7/1/24. Hospital charged Rs. 30,000/-, which hospital received. It is signed by accountant of hospital, contents of bills are correct, marked as **Exh. 62.**

4] Now I am referred with 6 pharmacy bills issued by Abhiyog Medical which is attached to Abhyog Hospital. Patient namely Navin Rabari has been supplied with the medicines prescribed by me. Pharmacy must have received the amount mentioned in the bill. These are correct, marked as **Exh. 63 collectively.**

Cross-examination for respondent No 1 :

5] Respondent No. 1 proceeded ex parte, hence, no cross.

Cross-examination by Shri Modak, Advocate, holding for Shri C.B. Pande, learned Advocate for respondent No. 2 :

6] It is correct that fracture injuries were properly united and healed up and, therefore, implants came to be removed in the hospital. Condition of patient was stable and normal at the time of discharge. It is correct that patient was able to do his normal and day to day activities after the discharge. It is correct that I don't look after day to day activities of Abhiyog Pharmacy. It is correct that, therefore, I do not know whether the patient really paid the amount to pharmacy. Witness volunteers that I deposed on the basis of pharmacy bill. It is not correct that said patient did not pay hospital bill.
