[No. XXVIII (II) SCHEDULE V, ACT V, 1898]
(Sections 221,222,223 Code of Criminal Procedure)

1. Name and office of Magistrate & c, I, ¹ Barnali Dasgupta,
Additional Sessions Judge,

2. Name of accused person. Hereby charge you² 1.Mahadeb Ram, S/O- Lt. Ram Prasad Ram & 2.Rehena
Ram, W/O- Lt. Ram Prasad Ram of Kalandarbagh Ehayabani,
as follows --- P.S. & Dist. Murshidabad.

3. Cognizance of this Court of Session.

Firstly – That you being the husband and mother-in-law of Manisha Mondal, D/O Lt. Bablu Mondal, Kalandarbagh, P.S. & Dist. Murshidabad in furtherance of your since her marriage with Mahadeb Ram on 27.05.2020 subjected her to cruelty both mentally and physically for demand of more dowry at your house and that you thereby committed an offence punishable U/S 498A/34 of I.P.C and within³ the cognizance of this Court.

Secondly – That being the husband and mother-in-law of Monisha Mondal, D/O Lt. Bablu Mondal, Kalandarbagh, P.S. & Dist. Murshidabad in furtherance of your since her marriage with Mahadeb Ram on 27.05.2020 subjected her to cruelty both mentally and physically for demand of more dowry at your house and on 29.11.2020 at your house committed dowry death by causing the death of said Manisha Mondal and that you thereby committed an offence punishable U/S 304B/34 of I.P.C. and within³ the cognizance of this Court.

Thirdly – That on 29.11.2020 at your house Manisha Mondal, wife of Mahadeb Ram committed suicide and that you in furtherance of your common intention abetted its commission by subjecting her cruelty both mentally and physically since after marriage on 27.05.2020 for demand of more dowry and that you thereby committed an offence punishable U/S 306/34 of I.P.C. and within³ the cognizance of this Court.

4. In case tried by Magistrates omit “by the said Court”.

And I do hereby direct you be tried on the said charge.

Contents of charge so made out is read over and explained to the accused persons in Bengali language to which they pleaded not guilty and claimed to be tried.
