

CHARGE WITH FOUR HEADS
[No. XXVIII (II), Schedule V. Act V. 1898]
(Sections 221,222,223, Code of Criminal Procedure)

- 1) Name and Office of I, ⁽¹⁾ Suratheswar Mondal, Addl. Sessions Judge, 2nd Court, the Magistrate, etc Lalbagh, Murshidabad.
- 2) Name of accused I do hereby charge you ⁽²⁾ person. as follows :- 1. **Tonikul Sk.**
- 3) My cognizance or the cognizance of the Court of Session **Firstly**, that you on 18.05.2024 at about 8 pm committed house-trespass by entering into the house of the defacto complainant Nurnahar Khatun and that you thereby committed an offence punishable u/s.**448** of the I.P.C. and within³ the cognizance of this Court.
- Secondly**, that you on the same date, time and place wrongfully confined the defacto complainant Nurnahar Khatun at her house and that you thereby committed an offence punishable under Section **342** of the Indian Penal Code within the cognizance of this Court.
- 4) In cases tried by Magistrate, omit “by the said Court” **Thirdly**, that you on the same date, time and place attempted to commit rape upon Nurnahar Khatun forcibly and thereby committed an offence punishable under Section **376/511** of the Indian Penal Code within the cognizance of this Court.
- Fourthly**, that you since few days prior to 18.05.2024 used to give bad proposal to Nurnahar Khatun while she went outside of her house with an intention to insult her modesty and thereby committed an offence punishable under Section **509** of the Indian Penal Code and within the cognizance of this Court.

And I hereby direct that you be tried ⁽⁴⁾ by this Court on the said charge.

The contents of the charge are read over and explained to all the accused persons to which, each of the accused pleads not guilty by saying “Ami Nirdosh” and claims to be tried.
