The case is fixed today for appearance and further order.

Sole accused on court bail is present by filing hazira.

Perused the record. The case was already fixed for examination of the accused U/S 313 Cr.P.C. Accordingly, the record is taken up.

After considering the evidence adduced by prosecution, this Court find no necessity to examine the accused persons U/S 313 Cr. P. C.

Heard the argument.

Now the case record is taken up for passing order.

The prosecution stemmed out of a Court complaint filed by V.G alleging that on 21.07.2014 in the night , the accused entered into her room and tried to commit rape on her by putting her in fear.

On the basis of the said written complaint , policed started investigation and after completion of investigation, submitted charge-sheet against the accused persons U/S 448/376/511/506 of the I.P.C.

After commitment of the case, charge was framed against the accused U/S 448/376/511 of the I.P.C. to which the accused pleaded not guilty and claimed to be tried.

During trial of the case, the prosecution had examined the star witness for the prosecution, the defacto complainant. She did not turn up to the cause of the prosecution, as she admitted that she did not identify the person who entered in to her room. She also deposed that as per instruction of local people, she put her signature on the written complaint. She stated to have no grievance against the accused. That led the instant case to be a case of no evidence. Resultant thereto, the accused is entitled to be acquitted.

O R D E R E D

The accused person be set at liberty and sureties stand discharge from his bail bond.
