Hereby charge you²
as follows ---

1) Golam Nurjaman Sarkar @ Sipon Sarkar.
3. Cognizance of this Court of Session.

Firstly – That you Golam Nurjaman Sarkar @ Sipon Sarkar of Elahaiganj, PS & Dist. Murshidabad on 15.07.2020 one Sohagi Bibi committed suicide due to your provocation to commit suicide as you have been disturbing her and tried forcibly to marry her by way of giving criminal intimidation and that you thereby committed an offence punishable u/s 306/506 of the IPC and within the cognizance of this Court and I do hereby direct that you be tried on the said charges.
4. In case tried by Magistrates omit “by the said Court”.

And I hereby direct that you be tried⁴ by the said Court on the said charges.

Contents of charge so made out are read over and explained to the accused persons in Bengali language to which you pleaded not guilty and claimed to be tried.

Sole accused person namely, Golam Nurjaman Sarkar @ Sipon Sarkar on bail is present.

Ld. PP is present with CD. And Ld. Defence counsel is also present.

Ld. PP-in-charge has opened the prosecution case by stating the fact of the case as well as by describing the charges u/s 306/506 IPC as brought against the accused person and stating by what evidence he proposed to prove the guilt.

Perused the LCR and the CD in toto. Having heard the submission and having perused the materials as these are available before this Court this time, the Court finds prima facie materials u/s 306/506 IPC against the above named accused person namely, Golam Nurjaman Sarkar @ Sipon Sarkar for framing charge against him.

Accordingly, the charges u/s 306/506 IPC against above named accused person is framed in prescribed form and kept with the record. And the contents of the charges u/s 306/506 IPC are read over and explained in Bengali to the accused person namely, Golam Nurjaman Sarkar @ Sipon Sarkar to which he pleaded not guilty by saying in Bengali, “ami nirdosh” and he claimed to be tried.

Accordingly the case is fixed on 15.02.2023 for appearance and evidence.

Let the summons be issued upon the CS witnesses.
