

CHARGE WITH FOUR HEADS
[No. XXVIII (II), Schedule V. Act V. 1898]
(Sections 221,222,223, Code of Criminal Procedure)
SSL- 35 of 2024

- 1) Name and Office of I, ⁽¹⁾ Suratheswar Mondal, Addl. Sessions Judge, 2nd Court, the Magistrate, etc Lalbagh, Murshidabad.
- 2) Name of accused I do hereby charge you ⁽²⁾ person. as follows :- 1.Md Sajirul Sk @ Sajirul Sk, 2. Asura Bibi @ Ashura Bibi and 3. Robin Sk.
- 3) My cognizance or the cognizance of the Court of Session **Firstly**, that you all in furtherance with common intention on 18.01.2022 at about 7.30 pm committed house-trespass by entering into the house of the defacto complainant Humayun Sk and that you thereby committed an offence punishable u/s. **448/34** of the I.P.C. and within³ the cognizance of this Court.
Secondly, that you in furtherance with common intention, on the same date, time and place voluntarily caused hurt to the defacto complainant Humayun Sk and that you thereby committed an offence punishable under Section **323/34** of the Indian Penal Code within the cognizance of this Court.
- 4) In cases tried by Magistrate, omit "by the said Court" **Thirdly**, that you in furtherance with common intention, on the same date time and place voluntarily caused grievous hurt to the defacto complainant Humayun Sk and that you thereby committed an offence punishable under Section **325/34** of the Indian Penal Code within the cognizance of this Court.
Fourthly, that you / all of you on the same date, time and place outrage the modesty of the wife of the defacto complainant Humayun Sk and thereby you committed the offence punishable u/s **354/34** of IPC and which is within the cognizance of this court.
Fifthly, you all in furtherance with common intention on the same date, time and place came to the house of the defacto complainant and abused the defacto complainant Humayun Sk filthily and thereby committed an offence punishable under Section **506/34** of the Indian Penal Code and within the cognizance of this Court.
Sixthly, that you in furtherance with common intention, on the same date, time did commit acts, to wit assaulted with such intention and under such circumstances that if by that act you had caused the death of defacto complainant Humayun Sk, you would have been guilty of murder, and that you caused grievous hurt to defacto complainant Humayun Sk by assaulting him with iron rod, and that you thereby committed an offence punishable under Section 307 of the Indian Penal Code within the cognizance of this Court.

And I hereby direct that you be tried ⁽⁴⁾ by this Court on the said charge.

The contents of the charge are read over and explained to all the accused persons to which, each of the accused pleads not guilty by saying "Ami Nirdosh" and claims to be tried.
