2. Name of accused person. Hereby charge you² 1) Chandan Biswas.
as follows ---

3. Cognizance of this Court of Session. Firstly - That you had an affair with the victim Rupa Nath for about last 4 years and you promised her to marry but you denied to marry her and on 05.05.18 you finally denied to keep your promise and by this way you cheated her fraudulently and that you thereby committed an offence punishable U/S 417 of the IPC and within³ the cognizance of this Court.

Secondly – That you on 05.05.18 came to the victim’s house at Vivekananda Palli under PO, PS & Dist. Murshidabad and committed rape upon her at 10:30 pm and that you thereby committed an offence punishable U/S 376 of the IPC and within³ the cognizance of this Court.

Thirdly – That both of you at the same place, same time and same day threatened the victim by uploading some intimate video of her and demanded her assets and a motorcycle from her and that you there by committed an offence punishable U/S 506 of I.P.C. within³ the cognizance of this Court.

4. In case tried by Magistrates omit “by the said Court”. And I hereby direct that you be tried⁴ by the said Court on the said charge.

Contents of charge is read over and explained to the accused in Bengali language to which he pleaded not guilty and claimed to be tried.

Today the case is fixed for charge hearing.

Sole accused person namely Chandan Biswas on CB is present by filing hazira.

Learned PP in-charge Mr. Pulak Mukherjee and learned defence counsel are present. Considering the C.D, L.C.R and on submission of the Advocates both sides the charge hearing is taken place in open Court.

Heard the Ld. P.P.-in-charge and Ld. Defence counsel.

Perused the case record including the charge sheet.

The case record is taken up for framing of charge.

On careful perusal of the materials on record, it appears that the accused person had an affair with the victim and he promised to marry her demanded articles from the victim and committed rape upon Rupa Nath D/O Mihir Kumar Nath of Vivekananda Palli, PO, PS & Dist. Murshidabad on 05.05.2018 at 10:30 pm at her house.

So, prima-facie, there is ground to frame charge against the accused person for committing the offence punishable u/s- 417/376/506 of the I.P.C.

Accordingly, charge is framed against the accused person for offence punishable u/s. 417/376/506 of the I.P.C. in separate sheet which is kept with the case record.

The contents of charge is read over and explained to the accused. On being asked whether he pleads guilty, or not, the accused person pleaded not guilty by saying in Bengali, "ami nirdosh" and claimed to be tried.

Considering the charge hearing the case be fixed on 13th, 14th and 15th days of May, 2019 for evidence.

Prosecution to take steps accordingly for issuing summons upon witnesses.
