CHARGES WITH FOUR HEADS
[NO.XXVII(II) SCHEDULE V, ACT V, 1898]
(Sections 221,222,223, Code of Criminal Procedure)

I, Sri Tarak Nath Bhagat
Additional Sessions Judge,
4th Court, Murshidabad
Berhampore, West Bengal.

hereby charge you –

1)Diluwar @ Super Sk, 2) Ansarul Sk, 3)Saira Bibi and 4)
Manuwara Bewa as follows:-

Firstly, that you- on 12.06.2019 at 8 a.m. at village Chhaighari under P.S. Doulatabad, Dist. Murshidabad, in furtherance of common intention wrongfully restrained one Mainuddin Sk and that you all thereby committed an offence punishable under Section 341/34 of I.P.C., and within the cognizance of this Court.

Secondly, that you on the same date, time and place, in furtherance of common intention voluntarily caused hurt to Mainuddin Sk and his wife Nasima Bibi with lathi and that you thereby committed an offence punishable under Section 323/34 of I.P.C., and within the cognizance of this Court.

Thirdly, that you on the said date, time and place, in furtherance of common intention attempted to commit murder of Mainuddin Sk and his wife Nasima Bibi by assaulting them with lathi upon their person and that you thereby committed an offence punishable under section 307/34 of the Indian Penal Code, and within the cognizance of this Court.

Fourthly , that you on the said date, time and place, in furtherance of common intention criminally intimidated Mainuddin Sk and that you thereby committed an offence punishable under section 506/34 of the Indian Penal Code, and within the cognizance of this Court.

And I hereby direct that you be tried on the said charge.

Substance of the charge of the offence punishable under the aforesaid section so framed against accused persons as mentioned here-in- above is read over and explained to them in Bengali to which they pleaded not guilty and claimed to be tried.
