CHARGES WITH THREE HEADs
[No. XXVIII (II) SCHEDULE V, ACT V, 1898]
(Sections 221,222,223 Code of Criminal Procedure)

1. Name and office of Magistrate & c,

2. Name of accused person.

Hereby charge you²
as follows --- Ratan Mondal, S/O Judhisthir Mondal, Raichandpur,
P.S. Jiaganj, Dist. Murshidabad.
3. Cognizance of this Court of Session.

Firstly – That you were working as labour in the house of Sujata Majumdar, W/O Shri Suvayu Dutta of Raichandpur, P.S. Jiaganj, Dist. Murshidabad and since last one month from the date of incident you were continuously gave her illicit proposals. On 07.12.21 at about 9.30p.m you committed house trespass the house of said Sujata Majumdar with a criminal intent and that you thereby committed an offence punishable U/S 448 of I.P.C and within³ the cognizance of this Court.

Secondly – That you were working as labour in the house of Sujata Majumdar, W/O Shri Suvayu Dutta of Raichandpur, P.S. Jiaganj, Dist. Murshidabad and since last one month from the date of incident you were continuously gave her illicit proposals. On 07.12.21 at about 9.30p.m you committed house trespass the house of said Sujata Majumdar with a criminal intent and forcibly tried to commit rape on her but as she somehow raised alarm, her family members came and rescued her and that you thereby committed an offence punishable U/S 376 of I.P.C., read with Section 511 of the IPC and within³ the cognizance of this Court.

Thirdly – That you were working as labour in the house of Sujata Majumdar, W/O Shri Suvayu Dutta of Raichandpur, P.S. Jiaganj, Dist. Murshidabad and since last one month from the date of incident you were continuously gave her illicit proposals. On 07.12.21 at about 9.30p.m you committed house trespass the house of said Sujata Majumdar with a criminal intent and forcibly tried to commit rape on her but as she somehow raised alarm, her family members came and rescued her and at that time you threatred the family members of Sujata Majumdar with dire consequence and that you thereby committed an offence punishable U/S 506 of I.P.C. and within³ the cognizance of this Court.
4. In case tried by Magistrates omit “by the said Court”.

And I do hereby direct you be tried on the said charge.

Today is fixed for production of accused Ratan Mondal.

Accused **Ratan Mondal** is produced from J/C.

Learned P.P. in-charge and learned defence counsel both are present.

The case record is taken up for consideration of charge at the instance of both sides.

Heard both sides.

Perused the case record and police report. It appears from the case record as well as police report that there is sufficient materials to frame charge U/S-**448/376/511/506** of the I.P.C. against the accused person.

Learned public prosecutor opened the case by describing the charge to the accused person.

Considering the materials on record and in the case diary it appears to that *prima facie* case is made out against the accused person. Accordingly, charges U/S- **448/376/511/506** of the I.P.C. has been framed against the accused **Ratan Mondal** on separate sheet and filed with the case record.

The contents of charge is read over and explained to the accused person in Bengali to which he pleaded not guilty and claimed to be tried.

At this stage a bail petition has been filed by Ld. Defence Counsel on behalf of accused Ratan Mondal.

Copy served upon Ld. P.P. in-charge.

Heard both sides.

Perused the case record.

Considering all, it appears that subsequently warrant was issued against the accused considering his conduct towards the court but now he is in custody since 05.10.23. In this situation as charge already been framed against the accused person, this court does not find any necessity to keep the accused behind the bar and hence bail prayer is allowed.
