| 3) | My cognizance or the cognizance of the Court of Session | Firstly , that you all in furtherance with common intention on 20.05.2019 at about 6 am wrongfully entered into the land of Emajuddin Khan near the village Pathan para, under PS Lalgola, District Murshidabad and thereby committed an offence punishable under Section 447/34 of the Indian Penal Code within the cognizance of this Court. |
| 4) | In cases tried by Magistrate, omit “by the said Court” | Secondly , that you all in furtherance with common intention, on the same date time and place voluntarily caused hurt to Emajuddin Khan, Sadir Khan and Titon Khan with iron rod, pashli and shabol and that you thereby committed an offence punishable under Section 324/34 of the Indian Penal Code within the cognizance of this Court.
Thirdly , that you all in furtherance with common intention, on the same date time and place voluntarily caused grievous hurt to Emajuddin Khan, Sadir Khan and Titon Khan and that you thereby committed an offence punishable under Section 325/34 of the Indian Penal Code within the cognizance of this Court.
Fourthly , that you all in furtherance with common intention, on the same date time and place voluntarily caused grievous hurt to Emajuddin Khan, Sadir Khan and Titon Khan with iron rod, pashli and shabol and that you thereby committed an offence punishable under Section 326/34 of the Indian Penal Code within the cognizance of this Court.
Fifthly , that you all in furtherance with common intention, on the same date time and place caused serious injuries upon Emajuddin Khan, Sadir Khan and Titon Khan with iron rod, pashli and shabol with such common intention and under such circumstances that if by that act you had caused their death, you would have been guilty of murder, and that you caused grievous hurt to them and that you thereby committed an offence punishable under Section 307/34 of the Indian Penal Code within the cognizance of this Court. |

And I hereby direct that you be tried ⁽⁴⁾ by this Court on the said charge.
The contents of the charge are read over and explained to all the accused persons to which, each of the accused pleads not guilty by saying “Ami Nirdosh” and claims to be tried.
