CHARGES WITH THREE HEADS

[No. XXVIII (II) SCHEDULE V, ACT V, 1898]

(Sections 221,222,223 Code of Criminal Procedure)

1. Name and office of Magistrate & c, I,¹ Mr. Salim Ahmed Ansari,
Additional Sessions Judge,
1st Fast Track Court,
Lalbagh, Murshidabad.
2. Name of accused person. Hereby charge you²
as follows --- 1) Kamala Mondal, 2) Arati Mondal, 3) Manajit Mondal and
4) Sanjay Mondal.
3. Cognizance of this Court of Session. Firstly – That all of you of village Char Rajapur, Paschim Colony, PS
Raninagar, Dist. Murshidabad on 27.08.2021 at about 16:00 hrs having common
intention committed house trespass by entering into the house of complainant with
intent to assault the father and mother of the complainant and that all of you thereby
committed an offence punishable under Section 448/34 of IPC and within the
cognizance of this Court and I do hereby direct that all of you be tried on the said
charge.
Secondly – That all of you on the same date, time and place in furtherance of
common intention voluntarily caused grievous hurt to the father and mother of
complainant by means of Hansua, iron rod and bamboo stick and that all of you
thereby committed an offence punishable under Section 326/34 of the IPC and within
the cognizance of this Court and I do hereby direct that all of you be tried on the said
charge.
Thirdly – That all of you having common intention, on the same place, date
and time did an act of assault with a view to kill the complainant's father and mother
by the act of the assault with Hansua, iron rod and bamboo stick and under such
circumstances that if by that act all of you had caused the death of the complainant'
father and mother all of you would have been guilty of murder (and that all of you
caused grievous hurt to the complainant's father and mother by putting them on
assault aiming at to kill them) and that all of you thereby committed an offence
punishable under Section 307/34 of the IPC and within the cognizance of this Court
and I do hereby direct that all of you be tried on the said charges.
4. In case tried by Magistrates omit "by the said Court". And I hereby direct that all of you be tried⁴ by the said Court on the said
charges.

Contents of charge so made out are read over and explained to the accused
persons in Bengali language to which they pleaded not guilty and claimed to be tried.

All the accused persons namely, 1) Kamala Mondal, 2) Arati Mondal, 3) Manajit Mondal and 4) Sanjay Mondal on bail are present.

Ld. PP is present with CD. And Ld. Defence counsel is also present.

Ld. PP-in-charge has opened the prosecution case by stating the fact of the case as well as by describing the charges under Section 448/326/307/34 IPC as brought against the accused persons and stating by what evidence he proposed to prove the guilt.

Perused the LCR and the CD in toto. Having heard the submission and having perused the materials as these are available before this Court this time, the Court finds prima facie materials under Section 448/326/307/34 IPC against the above named accused persons namely, 1) Kamala Mondal, 2) Arati Mondal, 3) Manajit Mondal and 4) Sanjay Mondal for framing charge against them.

Accordingly, the charges under Section 448/326/307/34 IPC against above named accused persons is framed in prescribed form and kept with the record. And the contents of the charges under Section 448/326/307/34 IPC are read over and explained in Bengali to the accused persons namely, 1) Kamala Mondal, 2) Arati Mondal, 3) Manajit Mondal and 4) Sanjay Mondal to which each of them pleaded not guilty by saying each of them in Bengali, "ami nirdosh" and each of them claimed to be tried.

Accordingly the case is fixed on 15.03.2024 and 16.03.2024 for appearance and evidence.

Let the summons be issued upon the CS witnesses.
