

Partition Suit No. 665 of 2025

Order No. 09 dated 09.04.2026

Today is fixed for hearing of plaintiff's temporary injunction petition and awaiting S/R and appearance of defendant no. 3 to 8.

Plaintiff is present by filing a petition supported by an affidavit, praying for extension of the ad-interim order of injunction.

Plaintiff also filed written objection against defendants' petition dt. 07.04.2026.

Today defendant no.1 filed two petitions, one u/S.151 of Civil Procedure Code praying for restoration of **status quo ante** and another under Order 39 Rule 1, 2 read with Section 151 of Civil Procedure Code praying for temporary injunction against defendant no. 3 to 7. Copy of both the petitions served upon the learned Advocate for the plaintiff.

Learned Advocate for defendant no.1 Bhagabati Mondal also submitted that inspite of Court's specific order vide order dt. 03.01.2026 as well as their repeated complaint police has not yet taken any tangible steps against the plaintiff and other defendants and flouting the order of interim injunction the plaintiff has raised some 'katcha ghar' in the suit property by almost dispossessing the defendant no.1.

It appears from the order dt. 03.01.2026 that by said order the Officer-in-charge, Jiaganj PS was directed to take all necessary steps to ensure that defendant no.1 shall not dispossess from her existing dwelling house, if any, in the suit property by any person, including the plaintiff, except in accordance with the due process of law.

However, no report has yet been received from said Police Officer regarding compliance of said order.

In the light of the alleged inaction by local Police inspite of specific order from this Court, I think a report should be called for from the O/C, Jiaganj PS regarding the steps he has taken in view of the order dt. 03.01.2026 of this Court.

Hence, O/C, Jiaganj PS is directed to submit a report before this Court on the next hearing stating the action he has taken in compliance of the order dt. 03.01.2026 of this Court.

Let a copy of this order along with copy of order dt. 03.01.2026 be forwarded in favour of O/C, Jiaganj PS for his information and necessary action.

Fixed **12.05.2026** for hearing of the temporary injunction petition of the plaintiff, the 151 petition today filed by defendant no.1 and awaiting report from O/C, Jiaganj PS.

DA to comply at once.

Written objection (if any) by the plaintiff against the petitions today filed by defendant no.1 to be filed in the meantime.

The ad interim order of injunction dated 25.09.2025 is hereby further extended till next date.
