punishable under section 379-B, 411 of Indian Penal Code, 1860
(hereinafter referred to as **IPC**).

2. As per prosecution story on 21.05.2018 ASI Manjit Ram, alongwith the police party was present at Lamba Pind Chowk in connection with patrolling where MHC informed that one mobile phone had been snatched in the area of Palta Factory Industry. On receiving the information ASI Manjit Ram alongwith police party went to the said place where Rinku came present and got recorded his statement to the effect that he is engaged in stalling chat, tikki stall in marriage functions. On 21.05.2018 he was going towards Mini Sabzi Mandi Industrial Area, to purchase vegetables and at around 9:00/10:00 PM when he reached opposite Palta Factory then two motorcyclists came from behind and the pillion rider had snatched his mobile phone Make Lava Company from his hands. He chased the boys and caught hold the pillion rider from his arm due to which he fell down and was apprehended with the help of people whereas the driver of the motorcycle ran away from the spot alongwith motorcycle and he can identify him if produced before him. The apprehended boy disclosed his name as Abhishek alias Abhi and he was handed over to the police. On the basis of his statement, ruqa was sent to the police station for registration of FIR. Statement of witnesses were recorded. On personal search of accused Abhishek Mehra one mobile phone make Lava company was recovered which was taken into police possession. During investigation Abhishek Mehra suffered a disclosure statement to the effect that he alongwith Vinay Gill was roaming on the road with the intention to snatch the mobile phone. Rough site plan was prepared and the recovered mobile phone was got identified

from the complainant. On 23.05.2018 ASI Manjit Ram alongwith police party was present at JMP Chowk in connection with investigation of the present case where secret information was received to the effect that Vinay Gill was standing at Tanda Railway Crossing line alongwith the motorcycle bearing no.PB08-DY-0914 to which ASI Manjit Ram reached Tanda Railway Crossing and with the help of police party he apprehended the motorcyclist who on his apprehension disclosed his name as Vinay Gill. Thereafter, he was arrested and the motorcycle used for commission of offence was taken into police possession. Site plan was prepared. Statement of witnesses were recorded. After completion of investigation, the challan against accused was presented in the court.

3. On appearance of accused in the court, copies of challan and necessary documents as relied upon by prosecution were supplied to them free of costs as required under Section 207 of Code of Criminal Procedure, 1973 (hereinafter referred to as **Cr.P.C.**).

4. On close scrutiny of facts mentioned in Police report and documents appended with it, accused prima facie appears to have committed offence punishable under section 379-B, 411 of IPC. As the offence punishable under section 379-B of IPC is exclusively triable by Court of Sessions, so this case is committed to the court of learned Sessions Judge, Jalandhar, for 04.09.2018. Both the accused on bail are directed to appear before the court of learned Sessions Judge, Jalandhar on 04.09.2018 at 10.00 a.m. sharp. Order of commitment be notified to the Public Prosecutor, Jalandhar. Ahlmad of this court is directed to send

the file, complete in all respects, to the court of learned Sessions Judge, Jalandhar well before the date fixed.
