applicant/accused Balkar Singh alias Rohi under Section 439 Cr.P.C, for releasing him on bail in this case bearing FIR No. 145 dated 31.12.2022, under Sections 307,34 IPC and section 25/54/59 Arms Act and offence under section 120-B,201 IPC added later-on, Police Station Moonak.

2. Upon notice, this application was contested by learned Addl.P.P for the State.

3. I have heard learned counsel for the accused/applicant, learned Addl.P.P. for the State and have gone through the file very carefully with their able assistance.

4. From perusal of the judicial file, this court finds that in this case bail was granted to the accused/applicant under section 307,34 IPC read with section 25/54/59 Arms Act vide order dated 19.04.2023. As per the case of learned defence counsel, later on section 120-B,201 IPC has been added and hence, prayed that accused be also released on bail in these sections also. When the accused has already been granted bail for main offence then no useful purpose will be served by detaining the accused in custody under section 120-B, 201 IPC which have been added later on by the police in the aforesaid FIR. Accordingly this bail application is hereby allowed and accused is also ordered to be released on bail under section 120-B,201 IPC and this order be read in continuation of the order dated 19.04.2023 which has been passed while allowing the regular bail application of the accused.
