POCSO TRIAL NO. 8 (05) 2026

Charges: **u/S. 6/18 of POCSO Act, alternatively, 64/62 BNS, 10 POCSO Act, alternatively u/s 75 BNS, 351(1)/115 BNSS**

Name of the accused:- **Goutam Konai**

Firstly, you on 09.01.2026 at about 5.45 PM at Kaliagachi, inside a bamboo bush, near crossing a bridge, under PS Lalgola attempted to commit aggravated penetrative sexual assault and in such attempt did certain act towards the commission of offence to wit caught hold of and dragged the VG causing her bleeding injuries, and thereby committed the offence punishable **u/S. 6/18 of the POCSO Act** and which is within the cognizance of this court.

Alternatively, that you, 09.01.2026 at about 5.45 PM at Kaliagachi, inside a bamboo bush, near crossing a bridge, under PS Lalgola attempted to commit rape upon female minor survivor aged about 17 years, and in such attempt did certain act towards the commission of said offence, to wit drag, applied criminal force and thereby committed an offence punishable u/S. **64/62 BNS** which is within the cognizance of this court.

Secondly, that you, 09.01.2026 at about 5.45 PM at Kaliagachi, inside a bamboo bush, near crossing a bridge, under PS Lalgola Dist. Murshidabad committed sexual assault along with physical assault leading to bleeding injuries upon minor female survivor and thereby committed an offence punishable u/S. **10 of POCSO Act**, which is within the cognizance of this court.

Thirdly, that you, 09.01.2026 at about 5.45 PM at Kaliagachi, inside a bamboo bush, near crossing a bridge, under PS Lalgola Dist. Murshidabad committed physical contact and advanced involving unwelcome and explicit sexual overtures and thereby committed an offence punishable u/S. **75(2) BNS** which is within the cognizance of this court.

Fourthly, that you, 09.01.2026 at about 5.45 PM at Kaliagachi, inside a bamboo bush, near crossing a bridge, under PS Lalgola Dist. Murshidabad committed criminal intimidation by threatening minor survivor injury to her person with intent to cause alarm to the said minor and thereby committed an offence punishable u/S. **351(1) BNS**, which is within the cognizance of this court.

Fifthly, that you, 09.01.2026 at about 5.45 PM at Kaliagachi, inside a bamboo bush, near crossing a bridge, under PS Lalgola Dist. Dist. Murshidabad voluntarily caused hurt upon minor female survivor and thereby committed an offence punishable u/S. **115(1) BNS**, which is within the cognizance of this court.

Under the above noted ground I hereby direct that you would be tried by this court on the basis of this charge framed above.

The contents of the charge is read over and explained to the accused person in Bengali language to which he pleads not guilty and claims to be tried.

Prosecution to take steps to that effect at once.
