

Order No. 8 , Dated 27.11.2025.

The record is put up by put up petition.

The accused/ petitioner ,namely, **Jonirul Sk** surrenders before this court and file a bail petition on the ground stated therein. He is taken into custody and remanded to J.C

A downloaded copy of dated 24.11.2025 in ref to CRM(A) 3540/ 2025 of the Hon'ble High Court along with photo copy of Adhar card of the accused persons is filed.

Ld. Advocate for the prosecution as well as the ld. Advocate for the accused is present.

Ld. Advocate for the accused person submits that the accused person is innocent and no bail petition of the present accused person is pending/rejected before any higher forum. He prays for bail.

Ld. P.P. in-charge leaves the matter before the discretion of this court .

Heard. Perused the case record .

It appears from the order of the Hon'ble High Court vide order dated 24.11.25 in ref with CRM(A)3540/2025 where Hon'ble Court has been pleased to observe that “ *in the event of arrest the petitioner shall be released on bail upon furnishing a bond of Rs. 10000/- with two sureties of like amount each one of whom must be local to the satisfaction of the Arresting officer and also be subject to the conditions as laid down under section 438(2) of the Code of Criminal Procedure, 1973 corresponding to Section 482(2) of the BNSS, 2023 and on the further conditions that the petitioner shall co operate with the investigation , shall met the investigating officer once a fortnight till submission of report in final form and shall not threaten or intimidate witnesses*”....

Considering the observation of the Hon'ble High Court vide order dated 24.11.25 in ref with CRM(A)3540/2025 an opportunity is hereby given to the accused person.

Accordingly, the accused person , namely, **Jonirul Sk** be released on furnishing local cash security of **Rs. 10,000/-**, and further Registered surity of Rs. 10000/- subject to the satisfaction of Ld. ACJM, Lalbagh, Murshidabad, along with condition imposed by the Honble High Court, Calcutta earlier.
