POCSO Case No. 50/25 (**PT -7(07)26**)

Charges: **u/S. 6 POCSO Act , alternatively 64(1) BNS**

Name of the accused:- **Jonirul Sk**

Firstly, that you about two year ago, from the date of lodging of complaint, at your house at Noncha under PS -Islampur committed aggravated penetrative sexual assault, several times, upon the minor survivor and thereby committed an offence punishable u/S. **6 of POCSO Act** which is within the cognizance of this court.

Alternatively , that you, about two year ago, from the date of lodging of complaint, at your house at Noncha under PS -Islampur committed rape upon minor girl, several times and thereby committed an offence punishable **u/S. 64(1) BNS** which is within the cognizance of this court.

Secondly, that you, that you, about two year ago, from the date of lodging of complaint , at your house at Noncha under PS -Islampur, married the minor survivor and thereby committed an offence punishable u/S. **9 Prohibition of Child Marriage Act** which is within the cognizance of this court.

Under the above noted ground I hereby direct that you would be tried by this court on the basis of this charge framed above.

The contents of the charge is read over and explained to the accused person in Bengali language to which he pleads not guilty and claims to be tried.

POCSO Case No. 50/25 (PT -7(07)26)

Charges: **u/S. 10 of Prohibition of Child Marriage Act & u/S. 21 POCSO Act**

Name of the accused:- **Momena Bibi, Eksad Ali , Lilufa Bibi**

Firstly, that you, about two year ago, from the date of lodging of complaint, at Noncha under PS -Islampur abated child marriage between Jonirul Sk and the victim girl, with common intention of you all and thereby committed an offence punishable u/S. **10 of Prohibition of Child Marriage Act** which is within the cognizance of this court.

Secondly, that you, since two year from the date of lodging of complaint, at Noncha under PS -Islampur failed to report the offence committed under the POCSO Act, which was within your knowledge, with common intention of you all and thereby committed an offence punishable **u/S. 21 POCSO Act** and which is within the cognizance of this court.

Under the above noted ground I hereby direct that you would be tried by this court on the basis of this charge framed above.

The contents of the charge is read over and explained to the accused persons in Bengali language to which they plead not guilty and claim to be tried.

Today is fixed for death report of co accused Tiyyarul Islam.

Out of five accused persons, four accused persons, namely, **Jonirul Sk, Momena Bibi, Eksad Ali, Lilufa Bibi** on bail are present and file hazira. The death report of Tiyyarul Islam is submitted by SI Ganesh Bhattacharya of Islampur PS.

Ld. Advocate for the accused and Ld. Special PP are present.

Heard both sides. Seen the death report along with death certificate. It appears that the accused Tiyyarul Islam @ Tiyyarul Islam has died on 28.11.2025. Accordingly this case is filed for ever, in respect of the accused Tiyyarul Islam.

The case is taken up for consideration of charge.

Perused the materials on record and CD. Considered.

After hearing both sides and considering materials on record a charge for the offences punishable under section u/S. 6 POCSO Act, alternatively 64(1) BNS and U/s 9 of the Prohibition of Child Marriage Act is framed against the prime accused Jonirul Sk and charge for the offences u/S. 10 of Prohibition of Child Marriage Act & u/S. 21 POCSO Act is framed against the other accused persons namely, **Momena Bibi, Eksad Ali, Lilufa Bibi** and is tagged in the case record.

The contents of charge is read over and explained to the accused persons in Bengali to which they plead not guilty by saying "Amra Nirdosh" and claim to be tried.

Fix 31.08.2026 for evidence of **de facto complainant and VG**.

To date for appearance/production of the accused persons.

Issue summons upon the witnesses ie VG and the defacto complainant accordingly.

Prosecution to take steps to that effect at once.

Alamats, if any, must be produced on all the dates of trial.
