

Order No. 09, dated 21.02.2025.

Record is put up by petition filed on behalf of accused/petitioner **Jahirul Mallick** who wants to surrender before this court.

Accused/petitioner Jahirul Mallick surrenders before this court. He is taken into custody and remanded to JC.

A bail petition is filed on behalf of the said accused/petitioner along with Vokatnama and certified copy of the order of the Hon'ble High Court, Calcutta dt. 12.02.2025, passed in CRM (A) 176/2025.

Copy served.

Heard both sides.

Ld. Advocate for the accused/petitioner submits that the accused/petitioner has been granted anticipatory bail by the Hon'ble High Court, Calcutta u/S. 482 of BNSS with a direction to appear before this court for regular bail within four weeks of passing of order of the Hon'ble High Court, Calcutta and in compliance of the said order of the Hon'ble High Court, Calcutta, the accused/petitioner voluntarily surrenders before this court.

Ld. Special P.P. submits that in view of order of the Hon'ble High Court, Calcutta, necessary order may be passed.

Perused the record including the order of the Hon'ble High Court, Calcutta dt. 12.02.2025, passed in CRM (A) 176/2025.

It appears that the present accused/petitioner has been granted anticipatory bail by the Hon'ble High Court, Calcutta vide order dated 12.02.2025 passed in CRM (A) 176/2025. CS has already been submitted.

Considering the facts and circumstances and in view of the order of Hon'ble High Court, Calcutta, the bail prayer of the accused/petitioner is allowed.

Accordingly, accused/petitioner **Jahirul Mallick** may find bail on furnishing bail bond of Rs. 10,000/- with two sureties of like amount each, subject to the satisfaction of this court, i.d. to J.C., with the condition as imposed by the Hon'ble High Court, Calcutta in the aforesaid order dated 12.02.2025.

The bail bonds to be furnished to be presented for verification in the office of Ld. ACJM, Lalbagh to check the fitness and capacity of the surety.

Put up the case record again for acceptance of the bail bonds after verification report from Ld. ACJM, Lalbagh.
