Record is put up today.

Now, case record is put up on the prayer of accused viz. **1) Durga Karmakar** and **2) Rinku Karmakar** who file through counsel authenticated copy of the Order passed by the Hon'ble Court in CRM (A) 3983 of 2023 while dealing with the application as filed at the instance of the petitioner accused herein U/s 438 Cr.P.C before the Hon'ble Court and intend to surrender before this Court.

Perused the certificate appended by the Ld. Counsel representing the petitioner/accused confirming the genuinity of the Order and also the identity proof documents accused/ petitioners.

Let these be kept with the record.

Perused the Order dated 14.09.2023 in CRM (A) 3983 of 2023 Wherein the Hon'ble Court has been pleased to determine CRM (A) 3983 of 2023 arising out of Murshidabad Police station Case No. 379 of 2023 dated 29.05.2023 U/s 363/365/376(2)(1)/34 IPC and Section 4/6/7 of POCSO Act and 9/10 of Protection of Child Marriage Act granting bail to **1) Durga Karmakar** and **2) Rinku Karmakar** U/s 438 Cr.P.C under the following terms .

“Accordingly, we direct that in the event of arrest, the petitioners viz. 1) Durga Karmakar and 2) Rinku Karmakar and 3) Sujan @ Purnendu Halder be released on bail upon furnishing a bond of Rs.10,000/- each, with two sureties of like amount each, to the satisfaction of the arresting officer and aslo be subject to the conditions as laid down under Section 438(2) of the Code of Criminal Procedure, 1973 and they shall appear before the Court below and pray for regular bail within four weeks from date.”

Accordingly the accused **1) Durga Karmakar** and **2) Rinku Karmakar** surrendereed before the Court and taken into custody.

Since the Hon'ble Court has set the terms of releasing the accused on bail and there seems no change of circumstances to reconsider the same, let the two accused be released on bail on same terms and conditions as detailed above and the copy of this Order with necessary documents including the copy of the order of the Hon'ble Court along with annexed documents be placed before the Ld. ACJM, Lalbagh facilitating submission of bond, which the petitioner/accused may furnish before the Ld. Court, embodying the condition mentioned in the Order of the Hon'ble Court and for further order.
