

Order No.11, dated 15.06.2026.

Today the date is fixed for bail hearing. Ld. Special PP on behalf of the State and Ld. Advocate on behalf of the accused/petitioner are present. A bail petition filed earlier on behalf of accused/petitioner, namely, **Mosaraf Hossain @ Bulbul** in connection with Lalgola PS Case No. 233/24, dt. 30.03.2024 ,praying for bail, is taken up for hearing.

Ld. Advocate on behalf of the accused/petitioner submit that the accused is in custody since long. He also submits by an affidavit that no bail petition of the present accused/ petitioner is pending/rejected before any higher forum and he prays for bail.

Ld. Special PP raises no objection against the prayer for bail of the accused/ petitioner .

The VG appears before the court submits that she is 18 years old and that he married with the accused when she was more than 18 years of age and that she has raised no objection against the bail .

Heard both sides.

Perused the materials on record and CD.

The defacto complainant also has no objection against the bail prayer of the accused. Further the contents of statement of the VG and the contents of the complaint are quite different. The VG has claimed to be in love affairs with the accused u/s 183 of the BNSS. Charge sheet has been submitted and no further detention of the accused is required for the purpose of investigation.

Considering the above, facts and circumstances of this case, gravity of the offences alleged, materials on record and CD, the accused/petitioners, namely, **Mosaraf Hossain @ Bulbul** be released on furnishing Cash security of **Rs.5000/-** , subject to satisfaction of Ld. ACJM, Lalbagh and with further condition to remain present during trial of this case unless restrained due to unavoidable circumstances .
