ORDERED

that accused person **A1** namely Gopal Mandal @ Gopinath @ Gopu is found not guilty of the charge labeled against him and he is acquitted as per the provision of section 235(1) of the Code of Criminal Procedure.

The accused person be discharged from his bail bond(s), if any; and be set at liberty forthwith but the accused person shall remain on fresh bail bond of ₹1,000/- with one surety for six months from this day as per the provisions of

Section – 437A of Cr.P.C and which bail bond(s) shall be accepted subject to the satisfaction of the Ld. CJM Malda with direction to appear before the Higher Court as and when such Court issues notice in respect of any appeal or petition filed against the Judgment and if, he fails to appear the bond shall stand forfeited u/s.446 of Cr.P.C.

The seized *Alamat*, if any, be destroyed after the period of appeal.

Let a copy of this judgment be sent to District Magistrate, Malda as per the provisions of Section 365 of the Code of Criminal Procedure.

Let a *pdf* copy of this judgment be sent to the Chairperson, DLSA, Malda through official mail with a request to inform the victim of his/her right to prefer an appeal availing Legal Aid.
