Accused namely Nur Mohammad s/o Mehedi Hossain is produced from JC.

Seized alams marked as Exbt.A and one sealed envelope stated to have containing a pen drive wherein the search and seizure process is videographed are produced before this Court.

Ld. Spl. P. P. is present.

Ld. Defence Counsel is present.

The I.O. SI Upendranath Roy of Kaliachak PS is present along with Case Diary. IO has prayed for taking the accused Nur Mohammad s/o Mehedi Hossain PC for 14 days.

Bail petition is filed on behalf of accused person.

Heard the I.O., Ld. P.P., Ld. Defence Counsel and the accused persons in person on the prayer of the I.O. for taking the accused Nur Mohammad s/o Mehedi Hossain PC for 14 days.

I.O. submits before this Court that to recover more narcotic substances, nab the other person involved in this case and to identify the racket of brown sugar dealings. Prayer of PC of the accused persons is required to be allowed.

Taking me to the relevant documents of the case docket Ld. Spl PP submits that if the PC prayer is not allowed, investigation would suffer.

Ld. Defence Counsel for Nur Mohammad s/o Mehedi Hossain and other hand submits that there is no necessity further PC. This accused is completely innocent and he should be enlarged on bail.

Perused the case record and case diary along with the statement of the accused person and P.C. prayer of the I.O. Considered.

The SDPO, Kaliachak, has recommended and forwarded the prayer of PC of accused Nur Mohammad s/o Mehedi Hossain.

407 gram brown sugar has been recovered from the possession of the accused Nur Mohammad s/o Mehedi Hossain. Considering the bunch of the documents to which Ld. PP has invited the attention of this Court and other

materials available in the case record I am of the consider view that for the sake of smooth investigation I am inclined to allow the prayer of P.C.

Considering the statement of the accused person and submission of the I.O. and the material available in the C.D., it appears to this Court that eight days (08) police remand will serve the purpose of the investigation. Hence, the prayer for police remand is allowed for 8 days. The I.O. of this case is directed to follow the guideline of Hon'ble Apex Court regarding the Human Rights of the accused person while in Police Custody. IO is further directed to produce the accused person before this court on 23-12-2024. Signature of the accused person is taken in the left margin of the order-sheet.

Accordingly bail prayer stands rejected.

Fix **23-12-2024** for production of the accused person, namely, Nur Mohammad s/o Mehedi Hossain from the police remand to this Court and report of I.O.

C.D. be returned.
