F.I.R. named accused person, namely, Nur Mahammad @ Nur Mohammad surrenders before this Court today by filing a petition praying for releasing the accused person as Hon'ble High Court has granted his bail u/s-438 of Cr.P.C. read with section 482 of the BNSS and in respect of that Ld. Advocate files downloaded copy of order dated 19-06-2025 passed by the Hon'ble High Court in C.R.M. (A) 1937 of 2025 along with affidavit affirmed by Ld. Advocate Abul Kalam stating that the above order of the Hon'ble High Court is genuine.

Ld. Spl. P.P. is present.

Heard both sides.

Considering the submission of the Ld. Advocate, I am inclined to act on the net copy of the order for the present subject to submission of original certified copy afterwards.

It reveals that the Hon'ble High Court, Calcutta has been pleased to grant anticipatory bail to Nur Mahammad @ Nur Mohammad U/S-438 of the Cr.P.C. read with section 482 of the BNSS in C.R.M. (A) 1937 of 2025.

Accordingly, the accused person, namely, **Nur Mahammad @ Nur Mohammad** shall be released on bail upon furnishing a bond of Rs. 10,000/-(Rupees Ten thousand only) with two sureties of like amount each, to the satisfaction of the arresting officer and subject to provision under section 482(2) of the Bharatiya Nagarik Suraksha Sanhita, 2023. The petitioner shall appear before the jurisdictional Court and pray for regular bail within two weeks from date.

Bail bond register is lying with the office of Ld. C.J.M. Malda. Hence, Ld. C.J.M. Malda is requested to fit the bail bonds and to send the same before this court at once.

To date, i.e. **19-07-2025** for production and ER of WA. .
