Today is fixed for hearing of bail petition, production, consideration of charge and ER of notice.

Accused person (01) namely **Md. Rahul @ Md. Jalil Hossain** is produced from J.C through V.C and remanded back to J.C.

One bail petition is filed on behalf of accused Md. Rahul @ Md. Jalil Hossain.

Bail petition is moved by the Ld. Defence Counsel.

Ld. Advocate for the accused prays for bail on any terms and condition.

VG and D/C are present. No objection mentioned.

However direct allegation of offence u/s 4 of POCSO Act against this accused.

Considering the gravity of the offence, bail prayer of the accused stands rejected.

Case is fixed up today for production and consideration of charge.

Ld. Spl. P.P opens the prosecution case and proposes to frame charge against accused person under section 4 of POCSO Act.

Considered the submissions made by Ld. Advocates for both sides and the contents of case record.

Having considered the materials in record I am of the considered view that there is a prima facie case and sufficient ground to frame charge against the accused person as proposed by prosecution.

Charge is accordingly framed against both the accused person namely Md. Rahul @ Md. Jalil Hossain under section 4 of POCSO Act.

Substance of charge is read over and explained to the accused person to which he pleaded not guilty and claimed to be tried.

Let the case be fixed up on **29-08-2026** for production and evidence of victim .
