This is an application for anticipatory bail submitted u/s 482 of BNSS on behalf of the accused/petitioner, namely **(1) Nur Jamal, (2) Dildar Hossain, (3) Aminul @ Aminul Hoque, (4) Julfikar @ Julfikar Hossain, (5) Dulali Khatun @ Dulali Bibi and (6) Channndni @ Chandni Khatun** in connection with Chanchal P.S. Case No. 45 of 2026 dated 15-01-2026 u/s 85/115(2)/118(1)/117(2)/3(5) of BNS adding Section 4 of POCSO Act and 9/10/11 of Child Marriage Act corresponding to Special Case No. 13/2026.

At the very outset, learned Counsel for the accused/petitioner submits before this court that no such application u/s 482 of BNSS is either pending and/or disposed of in the negative by the Hon'ble High Court Calcutta.

The case is fixed for hearing of the anticipatory bail petition of the accused.

Notice issued upon the de facto complainant of this case, but he has not appeared before this court.

Bail petition is moved on behalf of the accused.

Heard both the sides.

Ld. Advocate for the accused/petitioner submits that the accused are ready and willing to assist the I.O. in investigation of this case and their custodial detention is not necessary.

Ld. Public Prosecutor-in-charge opposes the prayer for bail regarding the principal accused and he prays for necessary order of this court regarding the other accused.

Perused the case record, CD and other materials on record.

It appears that the main allegation is against accused No. 1 Nur Jamal. His involvement in committing the alleged offence transpires from the materials on CD. In such circumstances, **anticipatory bail prayer of accused No. 1 Nur Jamal is rejected.**

Other accused are relatives of accused No. 1. Main allegation is not directed against them. They are ready and willing to assist the I.O. in investigation of this case. Their custodial detention seems not to be absolutely necessary for the sake of investigation.

Hence, it is,

ORDERED

that the accused, **(2) Dildar Hossain, (3) Aminul @ Aminul Hoque, (4) Julfikar @ Julfikar Hossain, (5) Dulali Khatun @ Dulali Bibi and (6) Channndni @ Chandni Khatun** may find anticipatory bail of Rs. 3000/- each with one registered surety of like amount each subject to satisfaction of Ld. A.C.J.M., Chanchal on condition to meet the I.O. of this case once in a week except the lady accused till submission of police report in final form.

The CrI. Misc. Case is thus disposed of.
