The application for anticipatory bail **U/s 482 of the BNSS** filed on behalf of petitioners **Sk Sahabur Rahaman and others** who apprehend arrest in connection with **Dhantala PS Case No.1089/2025** dated **23.12.2025** is taken up for hearing along with LCR and CD.

Heard both sides.

Perused the records.

While determining the present anticipatory bail application under section 482 of the BNSS in respect of the instant three accused/petitioners, it appears that this Court, with reference to **Dhantala PS Case No.277 of 2025 dated 19.04.2025 under sections 85/89/74/109/316(2)/351(2)/3(5) of the BNS**, was pleased to reject the anticipatory bail application of three accused persons, on the point of gravity of the allegation and injury, asking them to surrender before the concerned Learned Jurisdictional Court within fifteen days from the date thereof.

Now, it has been brought to the notice of this Court by the Learned Advocate for the defacto complainant and the Learned Public Prosecutor as well, that thereafter, the concerned Learned Jurisdictional Court was pleased to enlarge the accused persons on bail, **despite the fact that section 482 of the BNSS application was rejected by this Court on the earlier occasion.**

Now, the fact remains that the victim, after the said incident, was taken back to the in-laws house on the pretext of the dispute being settled between the parties amicably out of the Court, but to no good, so as to show that on 10.12.2025 she was again mercilessly beaten by the FIR named accused persons and was driven out and since thereafter, she was taking shelter at her father's house and while staying there, due to constant perseverance and instigation on the part of the inmates of her in-laws, **she committed suicide and that too, within a span of one year and six months, from the date of her marriage.**

In view of such facts, this Court feels it emergent to go through the CD of the said **Dhantala PS Case No.277 of 2025 dated 19.04.2025 under sections 85/89/74/109/316(2)/351(2)/3(5) of the BNS.**

It is brought to the notice of the Court that the previous case was ended in filing charge sheet and therefore, **GRO of the concerned Learned Jurisdictional Court is required to be asked** to transmit the said entire case record and the CD to this Court, **positively by 07.02.2026** for determining the present anticipatory bail application.

Let a copy of this Order be forthwith sent to the Learned ACJM, Ranaghat, for information and compliance.

Let another copy of this Order be sent to Investigating Officer of this case, at once, for compliance.

CD of the instant case be returned with direction to produce the same on the next date, fixed.

LCR be **retained**.
