No ER of WA has been received.

Accused persons namely Nizamuddin Sk, S/o- Lt. Hamid Sk, Village- Beldanga, College Road Beside Dimond Nursing Home, P.S- Beldanga, Nadia and Sheli Biwas, W/o- Nizamuddin Sk, Village- Bilkumari, P.S- Nakashipara, Nadia surrenders in the Court. They are taken into custody and remanded to J/C.

Accused persons namely Saikat Biswas and Jahanara Biswas on interim bail are present by filing hazira.

Ld. Advocate on behalf of the accused Nizamuddin Sk and Sheli Biswas files a petition for bail.

The copy of the bail petition served to the Ld. PP in charge.

Ld. Defence Counsel submitted that the accused persons were on bail and they are facing the trial in this case. However, on 11.07.2024 accused persons failed to appear in the Court and were absent without taking any step as such the W/A was issued against them. It is further submitted that accused persons could not appear before the court on the date fixed in time and as such W/A was issued against them. It is further submitted that the absence of the accused persons was unintentional on the previous date fixed and due to some unavoidable situation they could not attend the Court. Ld. Advocate further undertakes that accused persons shall appear in the Court on every date fixed without fail. Therefore, Ld. Defence Counsel prays for bail on any terms and condition.

Ld. PP in charge raises objection for grant of bail.

Heard both sides

Perused the case record.

It appears that the W/A was issued against the accused persons on 11.07.2024 after they were found absent without step. It further appears that accused persons are facing trial in this case and some of the witnesses including the defacto complainant has also been examined. It further submits that the defacto complainant and accused persons are living together. Considering the submission made before me and also the ground stated there in , I am inclined to allow the prayer for bail.

Accused persons Nizamuddin Sk and Sheli Biswas be released on interim bail of Rs. 6,000/- with two registered sureties of Rs. 3000/- each to the satisfaction of the Ld. CJM, Nadia on condition to appear before the Court regularly on every dates fixed without fail. The interim bail is valid till next date (10.07.2025) i.d. to J/C.

Recall W/A against the accused persons namely Nizamuddin Sk and Sheli Biswas.

The interim bail of the accused persons namely Saikat Biswas and Jahanara Biswas is confirmed.

To 10.07.2025 for appearance, if on bail/ ER of W/A.
