

Order No. 43 dated 15-09-2025

Three accused persons namely Kabijul Sk, Narendra Kumar and Yogesh Kumar are produced from JC as per direction and are represented by their ld.advocates. Accused Sanoj Kumar on CB is found present on call and his represented by his ld.advocate.

Ld. Spl. PP is present .

Today is fixed for appearance of the accused persons, production of the accused persons from JC, supply of copy and consideration of charge. Ld.Spl.PP submits that copies of supplementary charge sheet and relevant documents are ready to be supplied and accordingly the same are supplied to all the accused persons.

Now, the record is taken up for consideration of charge. It appears from the record that against accused Kabijul Mondal charge u/s.25A/25/27A/29 NDPS Act has already been framed and he pleaded not guilty on 23.04.2025. Similarly, against accused Sanoj Kumar charge u/s.27A/29 read with section 25A NDPS Act has already been framed and he pleaded not guilty on 23.04.2025 and against accused persons Yogesh Kumar and Narendra Kumar charge u/s.25A/25/29 NDPS Act has already been framed and they pleaded not guilty on 23.04.2025. The supplementary submission of charge sheet would prima-facie make out the case against all the accused persons for contravention of section 18(c) of Drugs and Cosmetics Act, 1940 punishable u/s.27(b) (ii) of the said Act.

Ld.Spl.PP opens the prosecution case by stating the materials collected against the accused persons. Heard ld.defence counsels on the point of charge. On hearing both the sides and considering the materials lying on the case record as well as case diary, I find that prima-facie case has well been made out against all the accused persons and accordingly, charge u/s.27(b)(ii) of Drugs and Cosmetics Act,1940 in contravention of section 18(c) of Drugs and Cosmetics Act, 1940 is framed against them and the same is read over and explained to them to which they pleaded not guilty and claimed to be tried.

After hearing the submission of ld.Spl.PP and ld.defence counsels, let the hearing of this case be fixed on the scheduled date(20.09.2025) as fixed for evidence of CSW-1.

Prosecution side is directed to take proper step to cause service of summons upon the witness in the mean time.

Accused namely Kabijul Sk, Narendra Kumar and Yogesh Kumar are remanded to JC with a direction of production. Accused Sanoj Kumar on CB is as before.
