Today case record is put up by two separate petitions on prayer of Ld. Advocate for the accused persons.

Accused **Tilu Mondal @ Tilu Khatun and Sonabhanu Bibi @ Mondal** surrender before this Court.

They are taken into custody.

Re-call W.A., if any.

Ld. Advocate for the accuseds has filed an application praying for bail along with a vakalatnama afresh.

Ld. Advocate for the accused/petitioner and Ld. P.P. both are present and they are heard.

Perused the materials on record. I find that it is a case of misuse of liberty and the accused/petitioner was earlier on bail and on the first day of appearance they remained absent and as such W.A. was issued against them. Today accused/petitioners have voluntarily surrendered before this court.

Considering all aspects of the matter, the bail application of the accused/petitioners is considered and allowed.

The accused/petitioners namely, **Tilu Mondal @ Tilu Khatun and Sonabhanu Bibi @ Mondal** may find **an interim bail** of Rs. 4000/- each with two sureties of like amount of Rs. 2000/- each, other than previous sureties, subject to satisfaction of Ld. Chief Judicial Magistrate, Nadia i.d. J.C. with further condition that they shall appear physically on each date till further order.

To dated (16-05-2026) for appearance, if on bail.

Ld. Advocate representing accused **Alibuddin Mondal @ Alibardi Mondal** filed a petition praying for bail of the accused.

Perused the bail prayer which has been objected by Ld. P.P.

Heard Ld. Advocate for the petitioner and the Ld. P.P. as well.

Having perused the bail petition and having heard the Ld. Advocate for the petitioner and the P.P. as well, it appears that previously accused was on bail but he has misused the liberty thereof and subsequently, warrant of arrest was issued against him and by virtue of the same he was produced before this court on 27-02-2026 and since thereafter he is in custody.

Considering the aforesaid facts and circumstances, I am inclined to allow the prayer for bail as made on behalf of the accused/petitioner.

The accused/petitioner namely, **Alibuddin Mondal @ Alibardi Mondal** may find **interim bail** of Rs. 4000/- with two sureties of like amount of Rs. 2000/- each, other than previous surety, subject to satisfaction of Ld. Chief Judicial Magistrate, Nadia i.d. J.C.
