

ORDERS ON BAIL PETITION

Sri. K.M.V.,/M.P.B., counsel for the accused No.1 to 4 has filed vakalath, surety affidavit, RTC extract, bail application under Section 480 of BNSS, 2023 for accused No.1 to 4 along with certified copy of order in CrI.Mis.No.116/2026 dated 11.02.2026 for accused No.1 to 4 granting the bail under Section 482 of BNSS passed by Hon'ble 1st Addl. District & Sessions Judge, Chitraduraga.

Learned APP received copy.

Perused the certified copy of CrI.Mis.No.116/2026 dated 11.02.2026 and heard both the side and I am of the opinion that, the offences alleged against accused No.1 to 4 persons is punishable under Sections 352, 115(2), 74, 351(2), 351(3) and 126(2) R/w Section 3(5) of BNS, 2023. The alleged offences are non-bailable in nature and they are not punishable with death or imprisonment for life. Hence, as the Hon'ble 1st Addl. District & Sessions Judge, Chitraduraga has already granted anticipatory bail to the accused No.1 to 4. This court is of the opinion that, accused No.1 to 4 is entitled to be enlarged on bail. Hence accused No.1 to 4 is entitled to be enlarged on bail under Section 480 of BNSS. Hence, I pass the following:

ORDER

Application filed by the accused No.1 to 4 U/
Sec.480 of BNSS 2023. is hereby allowed.

Accused No.1 to 4 is ordered to be granting
bail subject to following conditions;

CONDITIONS

- 1) The accused No.1 to 4 shall execute personal bond of Rs.50,000/- each with one surety to the like sum.
- 2) The petitioner/accused No.1 to 4 shall not tamper the prosecution witnesses and shall not make any efforts to destroy the evidence to be collected by the prosecution.
- 3) The accused No.1 to 4 shall not give threat to complainant and also any prosecution witnesses in any manner.
- 4) Accused No.1 to 4 shall not involve in any crime.
- 5) Accused No.1 to 4 shall appear before the Court concerned on all dates of hearing unless prevented by any genuine cause.
- 6) If accused No.1 to 4 violated any of the conditions as stated above, this bail order shall be cancelled.

Chitradurga District, offered her as surety for the

release of the accused No.1 to 4. She has also produced attested copy of her Aadhar ID Card along with RTC Extract pertaining to Re.Sy.No.45/2, measuring 3 acres 19 guntas, situated at Obannanahalli Village, Thalak Hobli, Challakere Taluk, Chitradurga District worth of Rs.15,00,000/-.
