Accused persons namely Jibrail Karikar @ Jibu, Tujam Sk, Tapas Sk @ Samsuddin Sk and Nazim @ Najim Sk on CB are found present on call and are represented by their Id.advocates. Two other accused persons namely Sashankar Biswas @ Babu @ Sashankha Sekhar Biswas and Morjel Sk are produced from Correctional Home and are represented by their Id.advocate. Ld.Spl. PP is present.

Today is fixed for production of the accused persons, appearance of the accused persons, supply of copy and consideration of charge.

Ld.Spl. PP submits that copies are ready to be supplied to the accused persons and accordingly, copies are supplied to all the accused persons.

At this stage, a bail application is found submitted on behalf of the accused namely Morjel Sk by his Id.advocate.

Now, the application for bail is taken up for consideration. The Id. advocate representing the accused person by filing an application prays for bail on the simple ground that he is lying in custody since 14.05.2025 and previous he was arrested in connection with NDPS Case No.22/25 on 22.03.2025 and was detained in judicial custody and after conducting jail interrogation prayer for production warrant was made on 14.05.2025. It is submitted that co-accused person has been released on bail by Hon'ble High Court and nothing has been recovered from the possession of the accused and charge sheet has been submitted and he standing on the same footing, prays for bail.

Heard Id.Spl.PP who raises objection on the ground that the allegation against the accused and others is very severe in nature as 12000 bottles of Phensedyl were recovered. It is submitted that prosecution is ready to conduct trial after framing of charge and at this stage, if they accused is bailed out, the process of trial will be hampered and he prays that the prayer for bail be rejected.

Hd.both sides. Perused the case diary. Perused the case record .

It appears that charge sheet has been submitted and today copies are supplied to the accused persons. The seizure of 12000 bottles of Phensedyl in connection with this case cannot be overlooked. Considering the nature and gravity of the allegation, and taking into account the stage of hearing of the case, I am not inclined to allow the prayer for bail and the same is considered and rejected.

To 26.11.2025 for appearance of the accused persons on bail, production of the accused and consideration of charge.
