Accused persons namely, Tujam Sk, Tapas Sk @ Samsuddin Sk and Nazim @ Najim Sk on CB are found present on call and are represented by their Id.advocates. Two other accused persons namely Sashanka Biswas @ Babu @ Sashankha Sekhar Biswas and Morjel Sk are produced from Correctional Home and are represented by their Id.advocate. Accused Jibrail Karikar @ Jibu who is on CB in this case is absent as Id.advocate for the accused by filing an application submits that he is lying under detention in reference to other case, but no reference of that case is noted in the petition. Ld.Spl. PP is present.

Today is fixed for production of the accused persons, appearance of the accused persons on CB and consideration of charge.

Ld.Spl. PP submits that the case cannot be heard out on the point of charge due to absence of an accused namely Jibrail Karikar @ Jibu

At this stage, a bail application is found submitted on behalf of the accused namely Sashanka Biswas @ Babu @ Sashankha Sekhar Biswas by his Id.advocate.

Now, the application for bail is taken up for consideration. The Id. advocate representing the accused person by filing an application prays for bail on the simple ground that he is lying in custody for a considerable period . It is submitted that he has been falsely implicated in this case and he has his permanent home and hearth and there is no chance of abscondance or to evade trial and thus.he prays to enlarge the accused on bail on any condition.

Heard Id.Spl.PP who raises objection on the ground that the allegation against the accused and others is very severe in nature as 12000 bottles of Phensedyl were recovered. It is submitted that prosecution is ready to conduct trial after framing of charge and at this stage, if they accused is bailed out, the process of trial will be hampered and he prays that the prayer for bail be rejected.

Hd.both sides. Perused the case diary. Perused the case record .

It appears that charge sheet has been submitted and today is fixed for consideration of charge. But, due to absence of one of the accused persons as he is lying in custody in reference to another case, the hearing on the point of charge could not be done. The seizure of 12000 bottles of Phensedyl in connection with this case cannot be overlooked. Considering the nature and gravity of the allegation, and taking into account the stage of hearing of the case, I am not inclined to allow the prayer for bail and the same is considered and rejected.

To 17.01.2026 for production of the accused persons, appearance of the accused persons on CB and consideration of charge. Ld.counsel for accused Jibrail Karikar @ Jibu is to take appropriate step in the mean time so that his produce be secured on the next date positively.
