Accused persons namely Ravi Kumar, Ratnesh Kumar, Sushil Kumar @ Sushel Kumar, Rajib Biswas and Bapan Halder are produced from J.C as directed. Fresh Vakalatnamas are found submitted on behalf of accused persons namely Sushil Kumar @ Sushel Kumar, Rajib Biswas and Bapan Halder. The vakalatnamas be kept with the record.

Two compliance reports alongwith two seizure list are found received regarding attachment of property against the warntees namely Sona Dhara and Laxman @ Lakshman Ghosh. Let the reports be also kept with the file.

Today is fixed for production of the accused persons and supplying of copy and consideration of charge.

At this stage two applications seeking bail are submitted on behalf of the accused persons namely Ravi Kumar and Sushil Kumar @ Sushel Kumar. The applications are taken up for hearing. In the application submitted on behalf of Ravi Kumar it is submitted that he has been falsely implicated with this case on the mere fact that he was one of the drivers of the vehicle in question. It is submitted that at the time of interception he was not driving the vehicle and got down from the same and it is submitted to release him on bail on any ground.

The other application for bail as sought for on behalf Sushil Kumar @ Sushel Kumar is taken up. It is submitted by the Ld. Counsel that the accused is detained custody since 26.10.2024 with false allegation and he was nothing but the owner of the vehicle as seized and it is submitted to release him on bail on any ground.

Ld. Special P.P. by raising strong objection submits that after completion of investigation the charge sheet has been submitted finding prima facie proof of allegation against the accused persons. It is submitted that copies are ready to be supplied and prosecution is ready to commence trial after framing of charge at an early date and it is submitted to reject the prayer for bail.

Perused the bail petitions along with other materials on record. Perused the charge sheet. Heard both sides. Considered.

On perusal of the case record I find that on 18.03.2025 the case against five accused persons namely Sona Dhara, Narottam Biswas, Sushanta Ghosh, Sukdeb Biswas and Laxman Ghosh has already been filed for the present on receiving the execution reports of W/A and P/A on 18.03.2025 and today fixed for supply of copy as well as consideration of charge. Ld. Special P.P is ready with the copies as to be supplied to the accused persons. It is found from the record that charge sheet has already been submitted against the accused persons as well as others.

Hence, considering the nature and gravity of the allegations and the fact that copies are ready to be supplied to the accused persons for commencing trial after framing charge at an early date, I am not inclined to allow the prayer for bail as prayed for. Both the petitions seeking bail are **considered and rejected**.

The copies as ready are supplied to the accused persons namely Ravi Kumar, Ratnesh Kumar, Sushil Kumar @ Sushel Kumar, Rajib Biswas and Bapan Halder in presence of their Ld. Counsel.
