Accordingly charge is framed against the accused person under section **376/511 of I.P.C** in separate sheet which is kept with the case record.

The contents of charge is read over and explained to the accused person in Bengali. On being asked the accused person pleaded not guilty by saying “Ami Nirdosh” and claimed to be tried.
