01	25.11.24	Received a case record along with FIR, written complaint, seizure list, forwarding report, memo of arrest, check list, medical slip, notice, inventory prayer and closed envelope from Ld. ACJM Tehatta Court Nadia. Accused namely Abu Taher Mondal is produced from Controller Tehatta Sub Correctional Home Nadia. I.O prays for 03 (Three) days PC in respect of accused namely Abu Taher Mondal. Learned Advocate for the accused namely Abu Taleb Mondal files petition praying for bail on the ground that the accused person has been falsely implicated in this case and he is the permanent resident of the jurisdiction of this Court and he has no intention to evade the justice. So he prays for bail on any terms and conditions. Learned special P.P. raised objection and submitted before the Court that the accused person was arrested along with Ganja without any valid document. So, he prays for rejection the petition praying for bail. Heard. Considered. Considering the recovery of contraband articles and considering the serious nature of offence, the bail prayer stands rejected. I.O. files a petition praying for police remand for 3 (three) days of the accused and the said prayer was duly forwarded by the SDPO, Tehatta. Ld. Special P.P. is present and prays for remand of the accused persons for 3 days. Accused person is heard in person and he submits that he has no injury in his body. I.O. is present with the C.D. Heard both sides. Perused the entire materials on record. Considered. It appears that the recovered Ganja is only 5 Kg 816 Gram which is non-commercial and I think no fruitful result will come during PC period. So, the prayer of the I.O. is thus rejected. Accused be remanded to JC.
