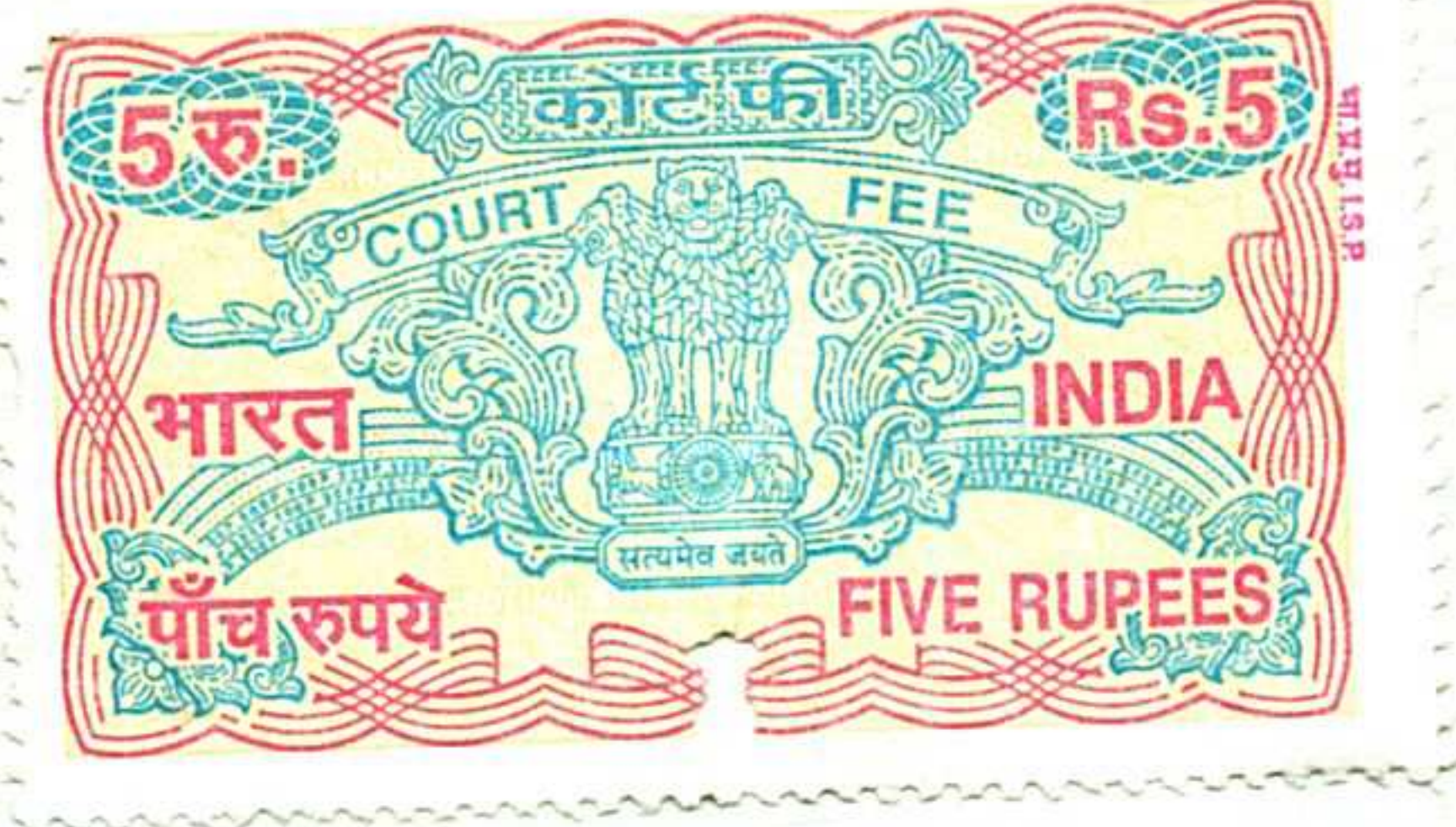

That the dead body of said deceased Madhabi Banerjee the mother of the petitioner was cremated at Nabadwip Burning Ghat on 19/07/1975 but the petitioner and her any family member could not be able to collect the Death Certificate of said deceased mother of the petitioner till today due to family difficulties/troubles. Moreover after demise of said mother of the petitioner, the petitioner and pro-respondent No.- 2 to 3 have been suffering from mental agony. As such the petitioner and pro-respondent No.- 2 to 3 could not be able to apply to the concerned authority of Nabadwip Municipality to enter/register the date of death of said deceased mother of the petitioner.
4. That it is mentioned here that no relief has been claimed against the pro-respondents but proper adjudication and collecting report regarding the cremation of said deceased mother of the petitioner, the chairman of Nabadwip Municipality has been made party as pro-respondent No.1. Other pro-respondents are the legal heirs of the deceased who made parties for proper adjudication of this case.

That now it is required to be entered/registered the date of death of the said mother of the petitioner namely Madhabi Banerjee W/o – Late Ratan Banerjee is/was the permanent resident of Srinath Banerjee Lane, Ramsita Para, P.O & P.S - Nabadwip, Dist.- Nadia, Pin-741302 as 19/07/1975 in the records and also required to be collected the death certificate of the said deceased mother of the petitioner from the respondent, otherwise the petitioner will highly be prejudiced which cannot be compensated any money value

Under the above facts and circumstances it is prayed before the Your Honour would be graciously be pleased to give a direction to the respondent to enter/register the death of the deceased mother of the petitioner namely Madhabi Banerjee W/o – Late Ratan Banerjee is/was the permanent resident of Srinath Banerjee Lane, Ramsita Para, P.O & P.S - Nabadwip, Dist.- Nadia, Pin-741302 as 19/07/1975 in the official records of the respondent and to issue the death certificate of the deceased mother of the petitioner in favour of petitioner.
