1. That the Plaintiff are bringing this suit in respect of 49 dec. of land and the dwelling house there on in Mouza No. 9 No. Bamanpukur under P.S. 4. That the defendants ill-motivatedly are trying to grab the entire suit property forcibly, the plaintiffs have any how resisted the illegal attempt of the defendants but the defendants given threat the they shall forcibly dispossess the plaintiffs from the suit property. The plaintiffs had inform to local Police Station about the matter but Local Police Station do not take any septs.
5. That there are no title, interest possession of the defendants over the suit property but the defendants of the local mussel power man and leader of the leading political party for that the defendants try to dispossess the plaintiff from the suit property and taking no other alternative, the plaintiff take shelter before the Court.

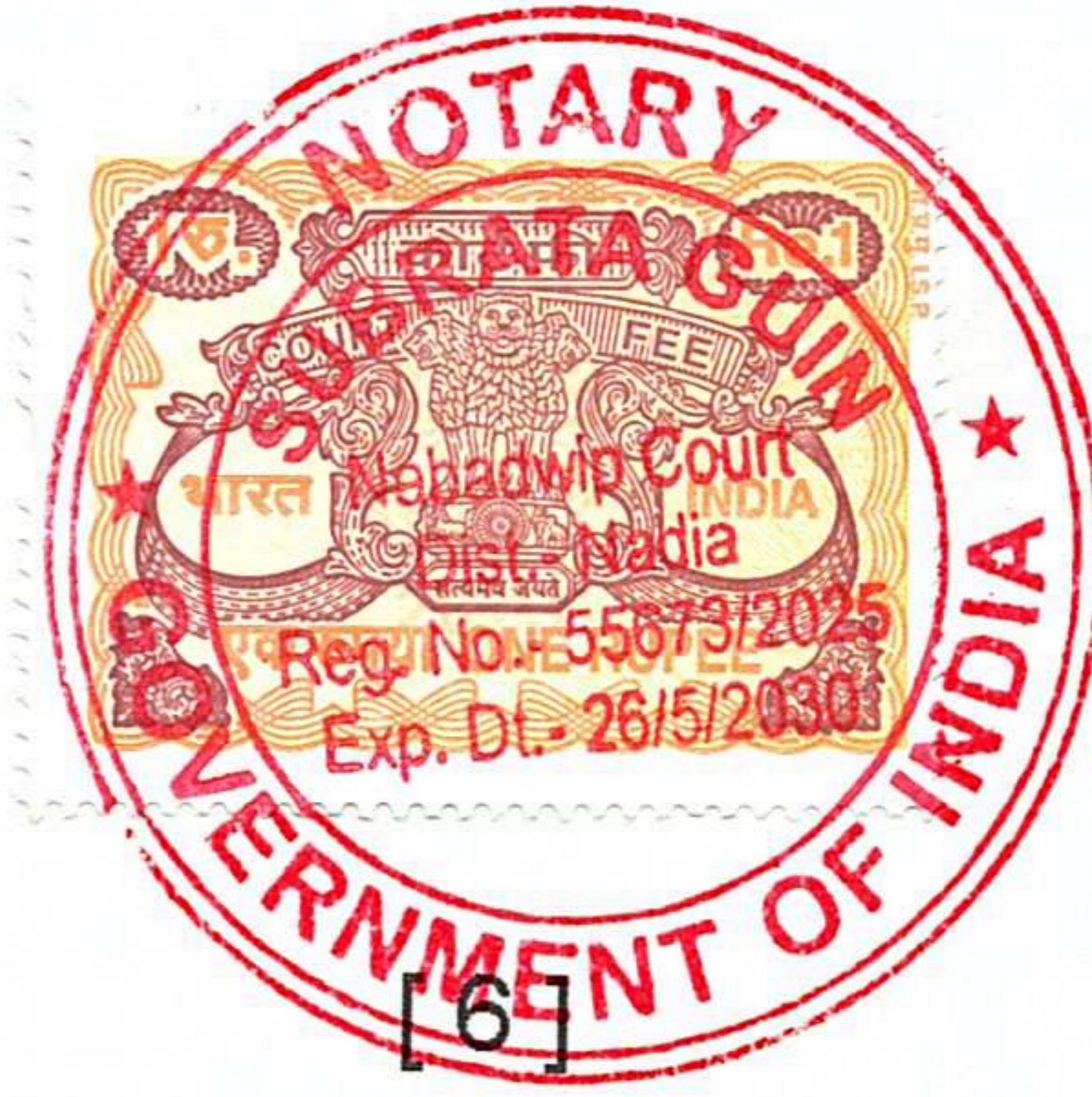
