**Suit Valued at Rs. 100/-.**

**MOST RESPECTFULLY SHEWETH,**

1. That the plaintiff is the absolute owner and possessor of the schedule property. That previously Kiriti Mohan Mondal was the actual owner and possessor of the schedule property. That Kiriti Mohan Mondal gifted his property to Hiranmoy Mondal by way of Regd. Gift deed being No. 1130 dated. 02.09.2005. After that the plaintiff have become the owner and possessor of the schedule property by way of Regd. Sale deed being No. 3659/2024 on 09.04.2024 executed by Hiranmoy Mondal and since then the plaintiff have been enjoying and possessing the schedule property by mutating his name in the L.R.R.O.R. and by paying Govt. Tax in his own name having his own Khatian No. 36164, peacefully and uninterruptedly.
2. That the defendant along with some other persons previously on 04/10/2025 tried to dispossess the plaintiff from the schedule property and at that time these plaintiff and some neighbors restrained them. After that on 09/11/2025 the present defendant with ill intention to grab the schedule property suddenly, forcibly and illegally entered into the schedule property and tried to

obstruct the construction work of the plaintiff over the schedule property. The plaintiff repeatedly requested the defendant not to enter into the schedule property, but the defendant did not care to that request.

3. That the defendant have no right, title, interest and possession in the schedule property. The defendant are trying to obstruct the construction thereon to grab the suit property and as such the defendant is required to be directed by an order of injunction to be passed by the Ld. Court not to create any obstruction in the construction work over the schedule property forcibly, illegally and without due process of law, otherwise multiplicity of proceedings will arise and the plaintiff will highly be prejudiced.

4. That the cause of action of this suit arose on and from 09/11/2025 and continuing thereafter day to day at suit place under P.S. Nabadwip, Dist. Nadia, within the jurisdiction of this court.

5. That for the purpose of Court fees and jurisdiction the suit is valued at Rs. 100/- as there is objective standard of valuation and by paying court fees on own valuation plaintiff filed this suit.

6. That under the fact and circumstances the plaintiff prays :-

a) That a decree for permanent injunction be passed against the defendant restraining him from making any disturbances in any way with the peaceful enjoyment over the property mentioned schedule.

b) That a decree for permanent injunction be passed against the defendant restraining him from making any construction work by the plaintiff over the suit property till the disposal of the suit.

c) Any other relief or reliefs.

d) Costs of the suit.

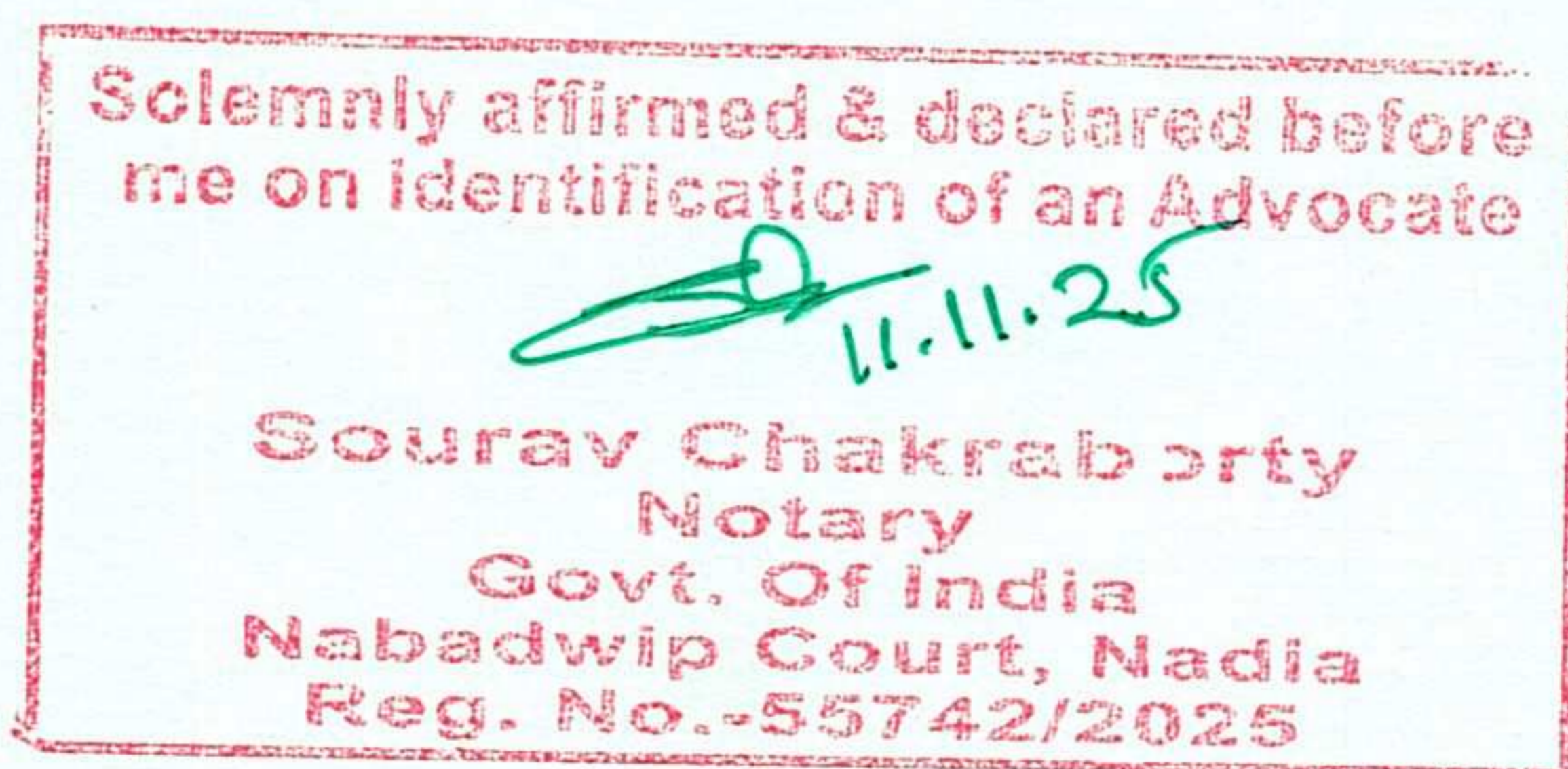
