This is an application U/s.483 BNSS filed by accused person namely **Meher @ Meherul Sekh**.

Hd. Ld. Lawyer for the petitioner and Ld. PP-In-Charge.

The Ld. Advocate on behalf of the accused person/petitioner submits that this petitioner was arrested and produced before the Court of Ld. A.C.J.M. Tehatta on 18.01.2026 and since then, he is in custody and no application u/s 483 of BNSS has been preferred any higher forum of Law. He has prayed for bail on any terms and conditions.

Ld. PP-In-Charge raises vehement objection against the prayer for bail.

Perused the F.I.R., C.D., statement of witnesses already recorded by the IO u/s 180 of BNS, statement of the victim lady u/s 183 of BNS and the seizure list.

This is a case u/s 140(3)/64/62/3(5) of BNS.

The allegation is that on 15.01.2026 at around 09:00 pm while the victim lady, after a family feud, was weeping sitting in front of a mosque, both the accused persons with a view to commit rape upon her, forcibly carried her to a plantain garden in their motorbike and both the accused persons tried to commit rape upon her at the said place and hearing the scream of the victim lady, the guards rushed there, following which both the accused persons fled away leaving their motorbike at the PO.

The seizure list dated 17.01.2026 reveals that a motorbike by which both the accused persons allegedly carried the victim lady has been recovered by the police. It also appears that investigation is still in progress.

Considering the seriousness of the allegation, the statement of the victim lady u/s 183 of BNSS, the seizure list and other materials in CD and also considering that investigation is still in progress, I am not inclined to allow the prayer for bail of the accused / petitioner.

Accordingly, the bail application of the accused / petition stands **rejected**.

C.D. & T.C.R. be returned.

The Misc. Case stands disposed of.
