At the time of inspection, we notice that said accused Khokan Molla was enjoying electricity at his premises by way of tapping and hooking from the local LT Line.

Thereafter, we disconnected the line and seized the hooking device along with the wire and the Seizure List was prepared.

Thereafter, we all returned to Rajarhat P.S and there our Asstt. Engineer lodged the FIR against said accused and we deposited the seized items there.
