hereby charge
you as follows :

First, that you since the marriage between Lokesh Roy and Priya Bain @ Mona continuously inflicted mental and physical cruelty upon Lokesh Roy in furtherance of your common intention for causing death of Lokesh Roy and goaded into his personal life with various acts and forced him to stay with Priya in a rental home of Mahadev Mondal and for your acts of torture Lokesh Roy committed suicide by hanging himself and that you thereby committed an offence punishable under section 306/34 of Indian Penal Code and within the cognizance of this Court of Sessions. And I hereby direct that you be tried by this Court on the said charge.

The charge so framed has been read over and explained to the accused persons and they have pleaded not guilty and have claimed to be tried.

Prosecution has brought allegations under sections 306/34 of the IPC against the accused person.

Upon consideration and hearing of the prosecution and the defence, I find that there is sufficient ground for proceeding. The allegations under section 306/34 of the IPC are *prima facie* established against the accused person.

The substance of accusations have been read over and explained to the accused person and he pleaded not guilty and claimed to be tried.

A formal charge in Form 32, Schedule- II of the Code of Criminal Procedure is prepared and is on record.
